EXPLANATORY NOTE ON THE GREEK OFFERS

1) CEYLON TEA.

As Greece does not produce tea, it is obliged to import it abroad. The duty imposed is entirely fiscal and not protective, and so does not influence importation.

The importation of Ceylon tea is only a commercial matter, as there is a preference for Ceylon tea. No concession is possible on this item.

2) COPRA SHELLD.

The duty is 20 met. drach. and not 35 M.D.

A reduction from 20 to 15 M.D. is conceded.

3) COPRA UNSHELLED.

A reduction from 12 to 10 M.D. is conceded.

4) COCONUT OIL.

No concession is possible on this item as Greece is an oil producing country and has an important Oil industry; For this reason we have made a concession on the duty for Copra which is a raw material.

5) DISSICATED COCONUT.

We never imported this item, so it is unknown product to us. But if it is used for candies the duty is not important.

6) GRAPHIT.

The duty is very small and does not impede importation. We do not think that a reduction can be made.

7) COCOA BEAN'S.

The requested binding is accepted.

8) COCOA.

We accept reduction of duty from 250 to 180 M.D.

TARIFF NEGOTIATIONS - GREECE / CEYLON


