NIGERIA'S OFFER IN THE KENNEDY ROUND

Bearing in mind the accepted principle as enunciated in paragraph 8 of Article XXXVI to the General Agreement that "developed contracting parties do not expect reciprocity for commitments made by them in trade negotiations to reduce or remove tariffs and other trade barriers to the trade of less developed contracting parties",

Mindful of the ministerial resolution of the 21st of May 1963 and especially paragraph 8 of that document,


and

Aware of the recommendations of the UNCTAD, reference Annex AIII 4 and particularly paragraphs 10 and 11,

nonetheless,

If the United Kingdom government should be compelled as a result of these negotiations in the Kennedy Round to eliminate or reduce customs duties on tropical products of interest to Nigeria and in respect of which Nigeria enjoys preference in the United Kingdom market, Nigeria would be prepared as her contribution to the overall effort to liberalize trade, to accept the reduction in the margin of preference.

It should be noted that Nigeria's acceptance of any reduction in the margin of Imperial Preferences which may result from the United Kingdom liberalization of trade in tropical products to developing countries is a real sacrifice especially as the United Kingdom market accounts for a little over one third of the entire exports of Nigeria.

NIGERIA - REDUCTION OF CUSTOMS DUTIES

Communication from the Permanent Mission of Nigeria

The following communication, dated 7 December 1966, has been received from the permanent mission of Nigeria.

1. I have the honour to forward herewith a list showing commodities on which the Government of Nigeria have reduced import duties with effect from 24 November 1966.

2. I shall be grateful if you will convey this information to all contracting parties to the General Agreement on Tariffs and Trade and in particular, to the participants in the Kennedy Round of trade negotiations. I wish to draw attention to the fact that this unilateral action on the part of my Government has been taken in pursuance of my Government's belief in the liberalization of world trade. For a country which depends to a considerable extent on receipts from customs duties as a major source of revenue, this decision of my Government represents a major contribution to the Kennedy Round of trade negotiations.



Communication de la Mission permanente du Nigeria

Le Directeur général a reçu de la Mission permanente du Nigeria la communication suivante en date du 7 décembre 1966.

1. J'ai l'honneur de vous adresser ci-joint une liste des produits pour lesquels le gouvernement du Nigeria a réduit ses droits de douane à compter du 24 novembre 1966.
2. Je vous saurais gré de bien vouloir transmettre ces renseignements à toutes les parties contractantes à l'Accord général sur les tarifs douaniers et le commerce, et en particulier aux participants aux Négociations Kennedy. Je voudrais souligner que cette action unilatérale de mon gouvernement procède de sa confiance en la libéralisation du commerce mondial. De la part du gouvernement d'un pays pour lequel les recettes douanières sont une source de revenus majeure et très nécessaire, cette décision constitue une contribution hautement importante à la réalisation des objectifs des Négociations Kennedy.
