U.A.R. Initial Offer to the Kennedy Round of Trade Negotiations

In April 1962 the U.A.R. applied for membership of GATT and in October of the same year was unanimously accorded provisional accession.

The U.A.R. also notified the General Secretariat of GATT of its intention to submit an offer on the date agreed upon.

The U.A.R. has fully participated in the T.N.C., its various groups and sub-committees in conformity with the rules governing the procedure for the completion of its final accession to GATT within the framework of the plan laid down for the participation of less-developed countries in the Trade Negotiations as per document TN64/LDC/34.

In doing so the U.A.R. has been also guided by the resolutions adopted in the ministerial meetings of 1963 and 1964 which together with the exercises embarked upon in the Kennedy Round arrived inter alia at enabling the less-developed countries to increase their export earnings and thereby acquire at least part of their foreign exchange requirements essential for the carrying into practice of their development projects.

It might be superfluous to enumerate the developments that have taken place in the course of the present stage of the Kennedy Round of Trade Negotiations and in particular during the stage of confrontation and justification of which the outcome was far from being satisfactory and even frustrating for the U.A.R., since in justifying the inclusion in their exceptions lists of items of export interest to our country, the developed countries ascribed that to trading difficulties as well as the need to provide the necessary protection for certain domestic industries in difficulty.

It is needless to point out that these very difficulties are much stronger in the case of lessdeveloped countries and subsequently call for an urgent and more liberal consideration if they are to be properly tackled.

The U.A.R., however, is hopeful and confident that the participating countries will spare no effort to achieve the results aspired at in the field of trade liberalizations and in increasing the percentage share of the less-developed countries in international trade in both the agricultural and industrial sectors.

It is noteworthy that not all the major participating countries have made known either in whole or in part the agricultural offers, a fact which makes it rather difficult for the less-developed countries in whose economy agriculture represents an important sector - as in the case of the U.A.R. - to assess fully the benefits that might accrue to them from the present exercise.

The U.A.R. would also point out that notwithstanding the fact that its tariff in force implemented as from the lst of January 1962, and based on the B.T.N., is relatively low compared with those of some other countries even among the less-developed.

The following breakdown confirms that beyond doubt:

- 25% of the U.A.R. imports are already duty free;
- 26% of the U.A;R. imports are subject to rates ranging from 1% to 5%;
- 91% of U.A.R. imports are liable to duties of 6% to 10%;
- $18\frac{1}{2}$ % of U.A.R. imports carry a rate of duty varying between 15% 20%;
- 31% of U.A.R. imports bear the incidence of rates ranging from 25% 30%;
- finally only 14% of U.A.R. imports are dutiable at a rate of over 30%.

It is worth mentioning that U.A.R. imports of manufactures, semi-manufactures and raw materials carry a rate not exceeding 5% if not less and account for 51% of its total imports. Such items are usually imported from developed countries most of which are member of GATT.

The paramount objectives taken into consideration when working out the said tariff were:

1- Providing a reasonable standard of living for the majority of the population and especially ensuring the adequacy of foodstuffs and other essential supplies; with the result that imports of these items are duty free.

2- To enable domestic industry to produce at competitive prices. Raw materials as well as equipment and machinery required for industry are imported duty free. 3- Relatively high rates of duty are only imposed inasmuch as they are needed to provide the necessary protection for certain infant industries; which is a common and recognized practice.

4- The realisation of adequate financial resources necessary for the implementation of the country's development projects as far as public expenditure is concerned.

The U.A.R. is having recourse to tariffs as the means of protection as no other restrictions are imposed. This being so far reasons of balance of payment difficulties.

However, inspite of all the above mentioned factors the U.A.R. has been assiduously taking part in the Kennedy Round of Trade Negotiations as well as in other international forums concerned with the same subject, with the object of making its appropriate and positive contribution to the overall trade negotiations and to their ultimate success.

With this end in view, the U.A.R. submits the following initial offer:

1- To cover its contribution to the Kennedy Round of Trade Negotiations and covering at the same time the trade negotiation side of our full accession to GATT.

2- To negotiate with those willing of the participating less-developed countries ways and means of expanding trade among themselves.

3- While bearing in mind the provisions of the Resolutions adopted by the T.N.C. on 6th May 1964 in respect of reciprocity from less-developed countries, the U.A.R. is prepared to give a binding on certain items as per the lists attached. 4- Furthermore, the U.A.R. is prepared to make a 40% cut in duties on certain items indicated in the enclosed lists.

5- In addition to the above, the U.A.R. is prepared to make a 50% cut on certain other items indicated on the attached lists.

6- It is understood that the implementation of the U.A.R. offer depends upon the overall arrangements to be concluded in these negotiations.





#### Sir,

We have the honour to bring to your attention the following:

According to the resolution adopted at the GATT Ministerial Meeting in May 1963, the Trade Negotiations will cover all categories of products: primary, agricultural, manufactured, and semi-manufactured.

Taking into consideration the importance of the agricultural sector in world trade, the U.A.R. has scheduled its offer on agricultural products on the basis of 50% cuts on most of the articles falling within the chapters 1-24 of the Brussel's tariff nomenclature. Meanwhile, it is worthy to mention that most of the items falling within the following chapters are a matter of free duty or very low tariff duties:

- I Live animals
- II Meat
- III Fish
  - IV Milk, dairy products, eggs
