MULTILATERAL TRADE NEGOTIATIONS + SUPPLEMENTARY REQUEST
FROM SWITZERLAND BY GHANA

You may recall that during the recent informal consultations between you and the joint delegation of the ACP countries, the delegate of Ghana gave notice of his country's intentions to make a formal request for further reduction in the present GSP rate you apply to unwrought aluminium.

2. Consequent upon this notification, Ghana is now making the following supplementary request:

3. You may perhaps recall that in addition to Ghana the other main suppliers to the Swiss market are all developed countries, namely Norway, Israel, EEC, Austria, USA, Sweden and Japan. For this reason, my Government considers it appropriate for your Government to accede to this request in the spirit of the Tokyo Declaration.
