Tariff Concessions which the Government of the UNITED STATES OF AMERICA requests from the Government of the UNION OF SOUTH AFRICA.

NOTE: The attached list represents the concessions which the United States requests from the Union of South Africa in return for the benefits the Union will receive from United States offers in its Torquay negotiations. The United States reserves the right to make additions to the attached list in the event negotiations between the United States and the Union of South Africa develop beyond the limited scope envisaged at present.

Moreover, these requests are made on the understanding that the Union Government will offer satisfactory compensation for the modification of Schedule XVIII which it has proposed be made, pursuant to the provisions of Article XXVIII, quite apart from, and in addition to, the tariff concessions which the United States requests in the attached list.
