## **Professional Experience**

## Ministry of Foreign Affairs and Trade

Minister for Trade: December 2011 – present

As Korea's Trade Minister, Minister Bark has been an ardent advocate for the multilateral trading system. He contributed to the promotion of trade agenda in global forums such as APEC, World Economic Forum, G20 and OECD. He supported efforts to restore momentum of the DDA and other negotiations at the WTO. With his initiative, the Korean government hosted an international symposium on trade facilitation in Seoul in November 2012 in an effort to develop possible solutions to pending trade facilitation issues. Even in time of economic difficulties, he ensured Korea's trade policy and practices remain in line with multilateral trade rules and standstill commitments, which won favorable appraisal at the Korea's Trade Policy Review in 2012.

He has also been active in promoting WTO-plus FTAs as supplementary means to trade liberalization. Despite considerable political sensitivities in both Korea and the United States, he was instrumental in bringing about the entry into force of the Korea-U.S. FTA. He completed the negotiations for FTAs with Colombia and Turkey. He is currently overseeing bilateral FTA negotiations between Korea and Australia, Canada, Japan, Mexico and New Zealand. In an effort to deepen regional economic integration, he launched negotiations on a bilateral FTA with China, a trilateral FTA with China and Japan, and a plurilateral FTA embracing ASEAN, Australia, China, India, Japan, and New Zealand.

Minister Bark's extensive experience in negotiating with other governments of both developed and developing countries has given him in-depth understanding of the interests and trade negotiating objectives of a wide range of WTO Members. At a time when sharp divergences - both practical and philosophical - have emerged in the Doha Round and other trade negotiations, Minister Bark's insights into the various competing viewpoints will be invaluable in finding ways to bridge these gaps.

He made a great deal of efforts to coordinate different government ministries in the process of developing Korea's trade policy and its positions for trade negotiations. He also dealt with numerous groups that were particularly vulnerable to trade liberalization, including farmers' associations and small- and medium-sized enterprise representatives. By doing so, he was able to contain protectionist pressures in a turbulent economic period.

In addition to his expertise in trade policy and negotiation fields, Minister Bark accumulated the administrative and organizational skills required to manage large organizations.

## **Korea Trade Commission (KTC)**

Chairman: June 2007 – June 2010; Commissioner: May 1999 – February 2004

During his tenure as the chief administrator of Korea's trade remedy measures and laws. Minister Bark dealt with the issue of trade remedies not only from the public policy perspective, but also from the private sector's viewpoint. The experience that he gained while serving as Chairman of the KTC will enable him to deal effectively with the trade remedy issues that have become subjects of increasing disputes among WTO Members. He addressed many controversial situations to balance producers' and consumers' interests, which gave him a reputation as an effective conciliator who is very keen in facilitating communication among interested parties.

# Graduate School of International Studies (GSIS), Seoul National University (SNU)

Professor: March 1997 - present; Dean: September 2006 - September 2010

GSIS of SNU is one of the most prestigious academic institutions in Korea which provide interdisciplinary education on international issues. Minister Bark has taught numerous courses related to international trade including history of multilateral trade negotiations and political economy of trade policy. When Minister Bark served as Dean of the GSIS, he established a master degree program specialized in international development policy for developing country policy makers, which is fully funded by the Korean government. He significantly broadened the admission channels for students from developing countries and academic cooperation arrangements with developing country institutions. He played a critical role to make SNU much more attentive to capacity building efforts for global communities, especially less developed parts of the world.

## **Korea Institute for International Economic Policy (KIEP)**

Senior Researcher: November 1989 – April 1994; Vice President: June 1994 – February 1997

As one of the founding members of Korea's first think-tank with the exclusive mandate of supporting external economic policies of the Korean government, Minister Bark dealt with GATT/WTO issues in depth. During the Uruguay Round negotiations, he gave key intellectual support to the Korean government as a core policy advisor and led services negotiations. He drafted the first Trade Policy Review report for Korea in 1992. He participated in the Singapore WTO Ministerial Conference as a policy advisor. His conviction for multilateral negotiations to enhance the world trading system was strengthened during his years at the KIEP.

#### Office of the President

Senior Economist, Office of the Economic Secretary to the President: March 1993 – June 1994

Minister Bark worked for the Office of the President as a senior economist and was at the control tower coordinating Korea's negotiation positions during the final process of concluding the Uruguay Round. He also advised the Korean President for the first APEC Economic Leaders' Meeting held in Seattle in 1993. These experiences significantly refined Minister Bark's policy capacity at his early career.

## Korea Development Institute (KDI)

Research Fellow, International Trade Division: February 1987 – October 1989

KDI was established in 1971 as Korea's first government think-tank and has made a critical contribution to the successful economic development of Korea. His interest in development issues started at the KDI where he worked on national development strategy. His commitment to development assistance grew out of his personal history – a life that has matured in parallel with Korea's economic development. His firm belief in the role of trade policies to promote both economic development and growth has made him enthusiastic about sharing the aspirations, interests and concerns of developing countries.

#### **Georgetown University**

When Minister Bark was teaching at Georgetown University, he had a wide research network with researchers at various institutions including the Institute of International Economics, World Bank, International Monetary Fund and other universities.
