MONTHLY TRADE TRENDS: JUNE - JULY 2019



MERCHANDISE TRADE

UPDATED ON 26 SEPTEMBER 2019

Exports of selected traders improved slightly in July 2019 relative to June, with declines tapering off in most countries and positive growth registered in China and Japan. Imports also turned upwards relative to June, with top traders showing smaller relative declines and imports increasing in extra-EU trade, the United States and Japan.

TRADE IN COMMERCIAL SERVICES

Exports of selected traders mostly increased in July 2019, continuing a trend of lower, but continued, growth relative to 2018. Asian countries logged especially high export growth. Imports of commercial services exhibited even more positive results, with India registering especially robust expansion in July 2019.
