MERCHANDISE TRADE

Despite a mild lifting of lockdown measures across the globe regarding COVID-19, merchandise trade continued its downward trend in May 2020. Except for Chinese exports (down by 3%), all selected traders reported sharp declines. Exports from the United States recorded the most substantial contraction (-36%).

TRADE IN COMMERCIAL SERVICES

Global trade in commercial services contracted furthermore in May compared to the previous year. Border restrictions were maintained across the globe, thus limiting services trade, mostly those associated with travel restrictions. China reported for the second consecutive month, a milder decline in services exports (-6%) as the lifting of lockdown measures resumed.
