MERCHANDISE TRADE

UPDATED ON 23 OCTOBER 2020

Merchandise trade continued to decline for most regions in August 2020. China saw the only increase in merchandise registering 9% as world markets began to re-open and demand Chinese goods, including virus-related personal protective equipment. Merchandise imports fell across the board.

TRADE IN COMMERCIAL SERVICES

Exports of commercial services continued to decline year-on-year in every economy except China and the United Kingdom, which registered 6% and 1% growth. Imports of commercial services declined in every economy in August, a trend that has continued since the start of the pandemic in March.
