

MERCHANDISE TRADE

UPDATED ON 28 AUGUST 2020

Merchandise trade continued its downward trend in June 2020 although declines were not as steep in some economies, especially the European Union, reflecting a declining rate of Covid-19 transmission after being one of the initial hotspots. Chinese exports and imports were the only exceptions, logging modest growth of 1% and 3% respectively as the economy lifted lockdown measures.

TRADE IN COMMERCIAL SERVICES

Global trade in commercial services declined in every economy in June compared to the previous year. Border restrictions continued to remain in place, which limited travel services. The decline in merchandise trade further reduced goods-related services, including transport services.
