On the List of State Property Objects Exempted from Privatization

Presidential Decree No. 422 of 28 July 2000

Collection of Acts by President and Government of the Republic of Kazakhstan (CAPG) No. 29, 2000, p. 354

In order to ensure the state regulation of organizations and objects of a special strategic importance to the Republic of Kazakhstan, I resolve:

- 1. The Government of the Republic of Kazakhstan shall:
- 1) exempt from privatization and its phases the state property objects listed in the enclosure;
- 2) only make changes in the list upon coordination with President of the Republic of Kazakhstan;
- 3) make the additional list of the following objects to be retained in the state ownership for a certain period: state owned enterprises, state property objects and state shares in joint stock companies as well other companies, provided that the sate regulation of such objects is of a strategic importance to the national interests of Kazakhstan.
- 2. Make void Presidential Decree No. 2261 "On Urgent Measures to Develop Mass Sport in the Republic of Kazakhstan" of 4 may 1995.
 - 3. This Decree becomes effective on the day of signing.

Enclosure to Presidential Decree No. 422 of 28 July 2000

The List of State Property Objects Exempted from Privatization and its Phases

- 1. Land (except for the land which could be privatized within the limits of and in accordance with the laws of the Republic of Kazakhstan), subsurface resources, water, plants and animals.
 - 2. Natural areas under special protection.
- 3. Military and technical property, organizations and objects necessary for the national security of the Republic of Kazakhstan.
- 4. Main-line railway, public national motor roads included into the network of international state routes as well as highroads of national defense importance including their engineering utilities; navigable water routes, lighthouses, safeguards (beacons) and navigation marks regulating and assuring the safety of navigation.
- 5. Oil and gas main pipelines, inter-regional electricity transmission lines networks with 220, 500 and 1,150 kV voltage.
- 6. Water-storage reservoirs with waterside structures, waterworks facilities, impounding dams.
- 7. Medical organizations rendering first medical and sanitary aid in the countryside, organizations rendering specialized aid (blood centers, mother and child protection centers, radiation medicine centers; cancer, tuberculosis, HIV and AIDS hospitals; organizations treating infected, dermatovenerologic, and psychic patients),

as well as the medical organizations that are the only state medical organizations in the serviced oblast, town, rayon¹.

- 8. Organizations for the social protection of population, children communities, child care centers, retirement homes; hospitals and sanatoriums for the disabled, participants of the Great Patriotic War and equal persons, children and old people.
- 9. The state organizations of general secondary education that ensure the constitutional rights of citizens for education.
 - 10. Historical and cultural heritage objects under protection of the state.
