Resolution of the Government of the Republic of Kazakhstan No. 355 of 14 April, 2005

"Kazakhstanskaya Pravda" dated 16.04.2005 No. 89-90 CAGP of the Republic of Kazakhstan, 2005, No. 16, Article 193

In accordance with Article 225 of the Code of the Republic of Kazakhstan as of June 12, 2001 “On Duties and Other Compulsory Payments to Budget” (Tax Code) the Government of the Republic of Kazakhstan **RESOLVES**:

1. To approve the enclosed list of Kazakhstani goods determined in accordance with customs legislation of the Republic of Kazakhstan, produced in the territory of the Republic of Kazakhstan under the customs regime “Free Warehouse” and sold to the other part of the customs territory of the Republic of Kazakhstan, turnover of which shall be exempted from Value Added Tax.

2 This Decree shall enter into force from the 1<sup>st</sup> of January, 2005 and is subject to official publication.
