On Approval of the Rules of Creation and Operation of the Enquiry Point for Technical Barriers to Trade, Sanitary and Phytosanitary Measures

Resolution of the Government of the Republic of Kazakhstan No. 718 of 11 July 2005

For the purpose of implementing the Law of the Republic of Kazakhstan of 9 November 2004 "On Technical Regulating" the Government of the Republic of Kazakhstan **DECREES:**

1. To approve the attached Rules of creation and operation of the Enquiry Point for Technical Barriers to Trade, Sanitary and Phytosanitary Measures.

2. The present Resolution shall enter into force from the date of its signature.

Rules of creation and operation of the Enquiry Point for technical barriers to trade, sanitary and phytosanitary measures

1. The present Rules of creation and operation of the Enquiry Point for technical Barriers to Trade, Sanitary and Phytosanitary Measures (hereinafter referred to as the Rules) have been developed in accordance with the Law of the Republic of Kazakhstan "On Technical Regulating" of 9 November, 2004.

2. The Enquiry Point for Technical Barriers to Trade, Sanitary and Phytosanitary Measures (hereinafter referred to as The Enquiry Point) shall be created on the basis of the Enquiry Point for Interaction with the World Trade Organization Members on Issues Concerning Accreditation, Standardization, Metrology and Certification under the organizational subdivision of the Republican State Enterprise "Kazakhstan Standardization and Certification Institute" of the Committee for Technical Regulating and Metrology of the Ministry of Industry and Trade of the Republic of Kazakhstan in accordance with the procedure, established by legislation of the Republic of Kazakhstan.

3. The main functions of the Enquiry Point shall be as follows:

1) interaction with the WTO Secretariat, WTO members, international organizations with purpose to provide interested parties and foreign countries, upon their requests, with copies of the documents and information on:

existing or being developed normative legal acts in the field of technical regulating, standards, sanitary and phytosanitary measures (further- the SPS measures), changes to them and product or service conformity assessment procedures;

membership or participation of the Republic of Kazakhstan in the international organizations and international treaties on standardization, SPS measures, conformity assessment, bilateral and multilateral accreditations;

sources of publishing drafts of normative legal acts which are being developed and approved in the field of technical regulating, SPS measures, standards or information on them.

2) Placing information in the official publication of the authorized body in the field of technical regulating and information system for general use in form of notification.

4. For the purpose of implementing its functions, the Enquiry Point shall have a right:

to conduct seminars, workshops and other events concerning range of issues within the jurisdiction of the Enquiry Point;

to request and receive information and materials from stakeholders concerning technical regulating and SPS measures;

to interact with the WTO Secretariat, WTO members, international organizations in the area of technical regulating and SPS measures.

5. Termination of the Enquiry Point's activity shall be made in the order, stipulated by legislation of the Republic of Kazakhstan.

The Rules of completion and submission of notifications by the Enquiry Point on technical barriers to trade, sanitary and phytosanitary measures

The Rules are developed in accordance with Article 10 of the Law of the Republic of Kazakhstan "On Technical Regulating".

The present Rules shall establish order of completing and submitting notifications by the Enquiry Point on technical barriers to trade, sanitary and phytosanitary measures (hereinafter referred to as the notifications).

The present Rules shall be designed for the use of the Enquiry Point on technical barriers to trade, sanitary and phytosanitary measures (further – the Enquiry Point), as well as natural and legal persons and their associations, unions, activity of which is directly related to development of the normative legal acts in the field of technical regulating, sanitary and phytosanitary measures and other parties, participation of which is stipulated by the international agreements of the Republic of Kazakhstan (hereinafter referred to as stakeholders).

1. General provisions

1.Completion of the notifications shall be done for:

1) information on the approved or being developed normative legal acts in the field of technical regulating and sanitary and phytosanitary measures (hereinafter referred to as SPS measures), that may significantly impact on the international trade;

2) information on development of the draft, amendments and (or) additions or cancellation of the normative legal act in the field of technical regulating and SPS measures;

3) information on development of the draft, amendments and (or) additions or cancellation of the standards of the Republic of Kazakhstan;

4) information on the existing or being developed conformity assessment procedures for products, services;

5) information on the approved or being developed sanitary and phytosanitary rules;

6) information on the control and inspection procedures, production and quarantine regimes, approval procedures on the permissible level of pesticides and food additives, that are in force in the Republic of Kazakhstan;

7) information on the risk assessment procedures, factors to take into account and identification of the appropriate level of sanitary and phytosanitary protection;

8) information on the membership or participation of the Republic of Kazakhstan in the international and regional organizations and international agreements on standardization, conformity assessment, veterinary, plant protection and quarantine, accreditation, as well as in the bilateral and multilateral agreements in the framework of the Agreements on technical barriers to trade (hereinafter referred to as TBT) and SPS measures;

9) information on the sources of published drafts and approved normative legal acts in the field of technical regulating, SPS measures, standards and information on them.

2. The order of completing and submitting the Enquiry Point notifications

2. The Notifications, depending on the date of coming in force, shall be divided to:

- 1) regular;
- 2) urgent.

3. The regular notifications shall be submitted to the Enquiry Point by the information services at the stage of developing normative legal acts in the field of technical regulating, SPS measures, standards, changes to them and conformity assessment procedures for products, services with purpose to give interested members of the World Trade Organization (WTO) an opportunity to get familiar with intention of the country to introduce a specific regulation.

4. The urgent notifications shall be submitted to the Enquiry Point by the information services while approval of the normative legal acts in the field of technical regulating, SPS measures, standards, changes to them and conformity assessment procedures for products, services with purpose to notify interested WTO members on introduction of the specific regulation, related to urgent problems of protection of life and health of human, animals and plants, environment protection.

The order of completing urgent notifications in the framework of TBT and SPS Agreements is attached in the Annex 1.

5. The notifications to the WTO Secretariat, Committee on TBT, Committee on SPS measures and to the WTO members shall be submitted in English.

6. The Enquiry Point, through publication of information on the existing and being developed normative legal acts in the field of technical regulation, sanitary and phytosanitary measures, standards, changes to them and conformity assessment procedures for products, services, shall place them in the official printing of an authorized body and general purpose information system in form of notifications.

7. The Enquiry Point shall give identification number for the notifications, submitted to the WTO Secretariat, Committee on TBT, Committee on SPS measures and to WTO members.

8. The notifications shall be completed according to the forms, approved by the present Order.

9. The information, presented in the notifications, shall fully and clearly characterize notification object and degree of its compliance with the requirements of the international standards, instructions and recommendations of the international, regional and national organizations.

10. Each notification section should be completed. If no information, the records "not known" or "not identified" shall be put in the section.

11. The size of the notifications shall be not more than 2 pages, of A4 format, font - Times New Roman 12.
