On Amendments to the Regulation on the Procedure of Formation of the List of International and Regional (Interstate) Standards, and Case of their Absence - the National (State) Standards which Ensure Compliance with Requirements of the Technical Regulations of the Customs Union and Required for Conformity Assessment (Confirmation).

In accordance with Article 3 of the Treaty on the Eurasian Economic Commission of 18 November 2011 the Collegium of the Eurasian Economic Commission **decided**:

- 1. To amend the Regulation on the Procedure of Formation of the List of International and Regional (Interstate) Standards, and Case of their Absence the National (State) Standards which Ensure Compliance with Requirements of the Technical Regulations of the Customs Union and Required for Conformity Assessment (Confirmation) approved by the CU Commission Decision No. 629 of 7 April 2011 according to the <u>Annex</u>.
- 2. This Decision shall enter into force upon expiration of 30 days from the date of its official publication.

AMENDMENTS

to the Regulation on the procedure of the formation of list of international and regional (interstate) standards, and in their absence - the national (state) standards which ensure compliance with requirements of the technical regulations of the Customs Union and required for conformity assessment (confirmation)

Amend the Regulation on the procedure of the formation of list of international and regional (interstate) standards, and in their absence - the national (state) standards which ensure compliance with requirements of the technical regulations of the Customs Union and required for conformity assessment (confirmation) (hereinafter – the Regulation) approved by the decision of the Customs Union Commission No. 629 of 7 April 2011, as follows:

- 1. The first item of paragraph 2 shall be amended as follows:
- "The participants of the procedures provided by the Regulation are:
- Technical regulating bodies empower national authorities of the Parties, implementing and (or) coordinating the work on technical regulating;
- Standardization bodies national authorities of the Parties on standardization;
- The developers of draft technical regulations of the Customs Union the bodies of the Parties responsible for the development of technical regulations of the Customs Union, or legal entities of the Parties responsible for the development of technical regulations of the Customs Union and defined by the Commission on the basis of competition in the stipulated order;
- Bodies involved in development the concerned authorities of the Parties involved in the development of draft technical regulations of the Customs Union;
 - The Eurasian Economic Commission (hereinafter the Commission)";
 - 2. Paragraph 3 shall be amended as follows:

"Draft lists of international and regional (interstate) standards, and in their absence - the national (state) standards which ensure compliance with requirements of the technical regulations of the Customs Union and required for conformity assessment (confirmation) (hereinafter - the draft Lists) are developed in accordance with the on the Regulation on the procedure for the development,

adoption, amendment and cancellation of the technical regulations of the Customs Union, approved by the Eurasian Economic Commission. "

- 3. Paragraph 4 shall be amended as follows:
- "4. Simultaneously with the development of the first version of the draft technical regulations of the Customs Union the developer of draft technical regulations taking into account the proposals of bodies participated in the development of draft technical regulations, technical regulating bodies and standardization bodies shall ensure the development of a draft List of standards in the form prescribed in annex 1 hereto.

The list of standards may include international and regional (interstate standards - GOST), and in their absence, national (state) standards of the Parties which provide, on a voluntary basis, compliance with requirements of the technical regulations of the Customs Union, and (or) which contain research (tests) rules and methods and measurements, including the rules of sampling necessary for the implementation and execution of requirements of the technical regulations of the Customs Union and for implementation of of products, the use of which for the above purposes may provide a transition period.

The draft list of standards refers standards in the sequence specified in Annex 2 to this Regulation, for each requirement of the technical regulations of the Customs Union indicating specific elements of the technical regulations of the Customs Union.

If separate sections (paragraphs, subparagraphs) of the standard, not the standard as a whole apply in the implementation of the conformity assessment (confirmation) for compliance with the requirements of technical regulations of the Customs Union, the column 3 of the list provides a designation of these sections (paragraphs, subparagraphs).

Along with the draft list of standards the developer of the draft technical regulations of the Customs Union shall prepare proposals for updating them on the basis of the results of monitoring the development of relevant interstate standards in the 3 form set out in Annex 3 to this Regulation.

The developer of the draft technical regulations of the Customs Union shall prepare information on methods (tests) required for the application and execution of requirements of the technical regulations of the Customs Union and the implementation of conformity assessment (confirmation), and represent this information in the annex to the explanatory note to the list of standards in the form set in Annex 4 to this Regulation.

The explanatory note to the draft List should contain: a brief description of the standards included in the draft List; information on compliance of the standards included in the draft list with the international and regional standards;

rationale for the inclusion in the draft List of national (state) standards of member states of the Customs Union;

proposals to develop international standards confirming the compliance with the technical regulations of the Customs Union;

proposals to update the interstate standards contained in the draft List;

proposals to update the methods of measurement (test) for assessment of compliance with the common sanitary-epidemiologic and hygienic requirements for goods subject to sanitary and epidemiological supervision (control);

and other information.

4. The first item of paragraph 5 shall be amended as follows:

"In developing the draft List of standards the developer of draft technical regulations of the Customs Union:".

- 5. In the first item of paragraph 6, replace the words "draft List" with the words "drafts lists."
 - 6. Paragraph 10 shall be amended as follows:
- "10. The List approved by decision of the College of the Commission, as well as amendments to the List shall be published on the official website of the Eurasian Economic Commission."
- 7. In paragraph 11, replace the words "The bodies of the Parties on standardization" with the words "Standardization bodies of the Parties."
 - 8. Paragraph 13 shall be amended as follows:
- "13. The Parties shall ensure the preparation of proposals to update the List of standards at least once a year based on the results of the monitoring and implementation of the standards contained in the List of standards and submission of proposals to the Commission.

The College of the Commission on the basis of proposals by Parties, prepared according to the results of monitoring the standards application, shall ensure updating the List of standards."

- 9. Annex 1 to the Regulations shall be amended in the wording of Annex 1 to the amendments of the Regulation.
- 10. Supplement the Regulation with Annex 3 as revised in the wording of Annex 2 to the amendments of the Regulation.
- 11. Supplement the Regulation with Annex 4 as revised in the wording of Annex 3 to the amendments of the Regulation.
