**On Approval of the Schedule for Development of Technical Regulations of the
Customs Union in 2012-2013.**

In accordance with Article 3 of the Treaty on the Eurasian Economic Commission of 18 November 2011, the Council of the Eurasian Economic Commission **has decided:**

1. To approve the Schedule for Development of Technical Regulations of the Customs Union in 2012-2013 (**attached**).

2. To repeal the CU Commission Decision No. 492 «On Schedule for Development of Priority Technical Regulations of the Customs Union» of 8 December 2010.

3. This Decision shall enter into force upon expiration of 30 calendar days from the date of its official publication.
