Amending and Supplementing the Issuance of Certificates of Origin, Commercial Invoices, and Export Licenses for Exported Garments

The Minister of Commerce

- Referring to the 1993 Constitution of the Kingdom of Cambodia;
- Referring to Reach Kret of Norodom Sihanouk King of Cambodia of November 1, 1993 on the Appointment of the Royal Government of Cambodia;
- Referring to Reach Kret of Norodom Sihanouk King of Cambodia of October 24, 1994 on the Reorganization of the Royal Government of Cambodia;
- Referring to Reach Kret CS/RKN/0897/47 of August 7, 1997 on the Reorganization of the Royal Government of Cambodia;
- Referring to Kram No. NS/RKM/0196/16 of January 24, 1996 promulgating the Law on the Establishment of Ministry of Commerce;
- Referring to Anukret No. 54/ANK/<u>BK</u> of September 22, 1997 on the Organization and Functioning of the Ministry of Commerce;
- Referring to the Commission Regulation (EEC) No. EEC 2454/93 on the granting of Generalized System of Preference (GSP) and Most Favored Nation (MFN) status to Cambodia;
- Referring to the Agreement between the United States of America and the Kingdom of Cambodia on Trade Relations and Intellectual Property Rights Protection of October 4, 1996;
- Referring to the Agreement Relating to Trade in Cotton, Wool, Man-made Fiber, Non-Cotton Vegetable Fiber and Silk Blend Textile and Textile Products Between the Royal Government of Cambodia and the Government of the United States of America of January 20, 1999;
- Referring to the letter of the Council of Ministers authorizing the establishment of the Garment Factory Technical Inspection Committee No 100/SCN of February 3, 1997;
- Referring to the Resolutions of the meeting of the Council of Ministers of September 21, 1997;
- Referring to Prakas of the Ministry of Commerce No. 141/MOC/SCDN of April 29, 1997 on the Establishment of the Garment Factory Technical Inspection Committee;
- Referring to Prakas of the Ministry of Commerce No. 340/MOC/PRK of November 28, 1997 on the Establishment of the General Trade Preferences Department;
- Referring to Prakas No 338/MOC/PRK of November 28, 1997 on the Organization and Functioning of the Foreign Trade Department;
- Referring to the Textile Agreement which is acknowledged on February 3, 1999;
- Pursuant to the need to issue Certificates of Origin, Commercial Invoices and Export Licences in an effective manner.

IT IS HEREBY DECIDED

Article 1: The <u>supplement to to-Prakas No. 1437/MOC of May 25, 1999</u>, regarding the issuance of certificates of origin, commercial invoices, and export licenses for garments shall include:

<u>The issuance of a certificate of origin, commercial invoice, and license for export by air shall have</u> the following documents:

- Application for goods export of the interested company;
- Receipt issued by the <u>D</u>epartment of <u>A</u>edministration;
- Certificate of Processing issued by the Ministry of Industry, Mines and Energy;
- Inspection Report of <u>an</u> official of the General System Preferences Department;
- Invoice of the company;
- Packing list of the company; and
- Sales contract between the purchaser and interested company.

Article 2: The paragraph "By Air" of Article 1 of Prakas No. 3195/MOC of October 13, 1999, regarding the issuance of certificates of origin, commercial invoices, and export licenses for garments shall be modified and replaced as follows:

The issuance of licenses for the export of textile products:

The exportation to <u>the</u> European Union of categories 4, 5, 6, 7, 8, 15, 21, 28, and 73 shall comply with the following requirements:

• Cambodia Certificate of Origin "C/O" (one copy for the Foreign Trade Department).

Article 3: At the end of each month, the <u>D</u>director of <u>the</u> of Generalized System of Preference Department, <u>the dD</u>irector of <u>the</u> Foreign Trade Department, and <u>the D</u>director of <u>C</u>Kamcontrol shall collect documents related <u>to</u> export for joint verification within their own responsibilities and inspection, do-research any factory that applied for <u>a</u> certificate of origin, commercial invoice, and export license which failed <u>to</u> export such goods and to declare for cancellation of such export documents and report to the Minister for instructions.

Article 4: Any documents which are contrary to the provisions of this Prakas shall be abrogated.

Article 5: The Technical Director <u>G</u>eneral, <u>the</u> Director <u>G</u>eneral of <u>A</u>administration and <u>E</u>finance, <u>the D</u>director of <u>G</u>generalized <u>S</u>eystem of <u>P</u>preference Department, <u>the D</u>director of Foreign <u>T</u>trade <u>D</u>department, and <u>the D</u>director of <u>C</u>Kamcontrol of the Ministry of Commerce shall perform their respective roles to effectively enforce this Prakas.

Article 6: This Prakas shall enter into force from the date of its signature.
