IT IS HEREBY DECIDEDS

Article 1:___Both Cambodian and Foreign Companies_, which are have been registered with the Ministry of Commerce_shall, be allowed have the rights to to freely engage in trading_operate Import Export_activities business freely.

All <u>Itrading activities mport Export operation</u> shall be <u>subjectpaid to payment of tax as</u> determined by according to provision of law.

Article 2: _The <u>provision</u>decision as provided <u>stipulated under in Article 1</u> above shall not be applied to the

Investment Companiesy, which is are governed under the bye Law on Investment Law of the Kingdom of Cambodia.

<u>Trading activities</u> <u>Business objective regarding the Import Export shall be <u>listed filed</u> in the <u>schedule of activities</u>list of the field that <u>shall</u> not <u>entitled</u> be received the <u>exemption to investment incentives</u> as <u>stipulated provided in the Sub-Decree Anukret No.</u></u>
