DecreeOn Adoption of the Negative List

- Pursuant to Law on Government of Lao PDR, No. 02/NA, dated 6 May 2007;
- Pursuant to Enterprise Law, No. 11/NA, dated 9 November 2005;
- Pursuant to Recommendation of the Ministry of Industry and Commerce, No. 1557/IC, dated 31 August 2007,

The Prime Minister hereby decrees as follows:

- **Article 1.** The Negative List in the enclosed Annex "A" of this Decree is hereby adopted.
- Article 2. The Negative List means the list of the businesses which are highly sensitive notably to the national security, public order, fine tradition and culture and environment, and which shall be scrutinized and authorized by the relevant authorities prior to enterprise registration. The Negative List shall not mean a list of businesses prohibited to be operated in the Lao PDR.
- **Article 3.** The Government of Lao PDR promotes the strong growth of investments and business operations through the implementation of expeditious, simple and convenient one-stop-shop registration system which means:
 - For the business types which are not in the Negative List, the enterprise registration officer shall proceed with the enterprise registration, without seeking any approval from the relevant authorities, within 10 working days of the receipt of the relevant application.
 - For the business types which are in the Negative List, the enterprise registration officer shall immediately forward the relevant application to the relevant authorities who shall respond within 10 working days, except for those businesses requiring longer technical examination. Then the enterprise registration officer shall issue an enterprise registration certificate within 3 working days. In case of rejection, a written notice with rejection reasons shall be communicated to the applicant.
 - **Article 4.** The relevant authorities shall amend or issue their regulations on examination and authorization procedures which shall be comprehensive, clear and easy prior to enterprise registration for those businesses falling in the Negative List, in compliance with timeframes as set out in paragraph two of Article 14 of the Enterprise Law and this Decree.
 - **Article 5.** The relevant authority may propose the adjustment of the Negative List, within their responsibilities, as appropriate and necessary from time to time to the Government for consideration and approval.

It is prohibited for any other persons than the Government to change the Negative List or set timeframes in contradiction with the Enterprise Law and this Decree. Violators shall be subject to measures as set out in the Enterprise Law.

- **Article 6.** The relevant authorities shall revoke all their regulations on examination and authorization procedures prior to enterprise registration for those businesses not falling in the Negative List.
- **Article 7.** The relevant authorities shall promptly improve their existing regulations or issue new regulations as necessary to be clear, thorough and in compliance with laws and Government's regulations in order to enhance the supervision of existing enterprises under their respective responsibilities, such as: eligibility criteria, inspection, certification, approval or authorization for all businesses whether falling in the Negative List or not, as provided for in paragraph 2 of Article 230 of the Enterprise Law.
- **Article 8.** The Ministry of Industry and Commerce shall be the center to disseminate, guide, inspect, monitor and encourage the effective implementation of this Decree. All ministries, organizations and local administration authorities shall strictly implement this Decree.
- **Article 9.** This Decree is effective from the date of signature.
