NOTICE OF AMENDMENT TO

NOTIFICATION No 175/MOC ISSUED ON 04/04/1994

To: All Heads of Commerce Divisions, provincial, municipal and Vientiane and throughout the country

<u>Subject:</u> Regulations on prohibited categories of goods, both for export and import.

In order to comply with the Business Law and to provide a basic method for the management of commercial sector goods, the Ministry of Commerce is co-ordinating with other sectors on the regulations on banned categories of import and export goods. List No.1 lists those state-controlled goods, which cannot be imported or exported. List No. 2 lists those goods of a technical nature.

All authorized officers from all the various sectors are therefore requested to be responsible for the implementation of checking the regulated goods categories from the date of the receipt of this announcement.

The Ministry of Commerce is continuing to study and research those goods which will be added to or removed from the prohibited lists.

Lists No.1 and 2 are attached.

List No.1

Prohibited Goods for Import or Export With Reference to Article 13 of The Business Law of the Lao PDR.

1. **Banned Categories of Goods for Import**

- 1. Weapons of all kinds
- 2. All right hand drive vehicles
- 3. All animal parts, such as bones, hides, feet, wings, heads
- 4. Addictive drugs such as; opium, heroin, morphine, cannabis, pheutkatom¹, all substances and narcotics including those which affect the emotions and the nervous system, and poisons and chemicals which can be used for the production of narcotics.
- 5. Various medicines, containing the following ingredients

Framycetin

Caffeine

Amphetamine and similar substances

Bearing the trademarks: yabuathay² yatanchay, yabuatboula, yabuatdtkok, yadaka,³, Avilon, Colicidine-D and others.

- **Cultural Items** 6.
 - Any books, newspapers, magazines, pictures, and videos depicting Lao and foreign groups in a poor light abroad
 - Books on sociology and politics, and any literature which has the purpose of attacking and destroying the state, the Party or socialism in general
 - Pornographic books and magazines
 - Pornographic photographs, videos and films
 - Items for gambling purposes such as: cards and so on
 - Any items of clothing which flaunt tradition: such as revealing blouses, mini-skirts, shirts with inappropriate
- 7. Agricultural products which are produced domestically such as:
 - chilies
 - aubergines
 - tomatoes
 - bananas
 - sapota
 - lemons
 - other seasonal fruits
- 8. Dangerous chemicals and industrial products.

2. <u>Banned Categories of Goods for Export</u>

- 1. Rifles, guns, which have been fired, shotguns, any similar guns, bullets of all types, and all parts of guns.
- 2. Archaeological artifacts and antiques such as: ancient history books, histories of the country, Buddha images, ancient and valuable ornamental items belonging to local villages, rare coins, and any items of historical value registered with the Ministry of Information and Culture.
- 3. Any containers containing drugs such as: opium, morphine, heroin, cannabis, cocaine, *pheutkatom*, substances and narcotics of all kinds including those which affect the emotions and the nervous system, and poisons and chemicals which can be used for the production of narcotics.
- 4. All kinds of logs (except in special cases)
- 5. Timber of 15 x 80 cm and above (length is not limited)
- 6. All raw rattan and processed rattan.
- 7. All wild animals

^{*} The Ministry of Commerce strictly prohibits the import or export of all goods as specified above.

- all kinds of sweetstuffs (cakes, candies)

- drinks (pure water for drinking, alcohol and beer)

- all species of plants

3. All fertilizers, including chemical fertilizers

- videos and cassettes which are not in keeping with tradition
