#### **EXECUTIVE ORDER Nº 30**

EXTENSION OF EXECUTIVE ORDER NO. 24
SUSPENDING TARIFF ON ROAD CONSTRUCTION EQUIPMENT,
FORESTRY EQUIPMENT, AGRICULTURAL EQUIPMENT,
LIVE ANIMALS FOR BREEDING, AGRICULTURAL
SEEDS AND SPECIFIED MINING EQUIPMENT

- WHEREAS, to accelerate the pace of road construction and rehabilitation, the
  development of the forestry and mining sectors as well as agriculture production
  in Liberia, the Government of the Republic of Liberia has reviewed the tariffs
  imposed on essential road construction equipment, forestry equipment, specified
  mining equipment, agricultural equipment, and, live animals for breeding,
  agricultural seeds, and other goods related directly to agricultural development;
- 2. WHEREAS, the Government recognizes the increased need to stimulate activities in the above sectors after years of war; and also recognizes the need to provide incentives under the infrastructural and economic revitalization pillar of the Poverty Reduction Strategy by encouraging private sector investment in the procurement of essential road construction equipment, forestry equipment, specified mining equipment, agricultural equipment, agricultural seeds, and other goods related directly to agricultural development with the view, among other things, to attain self sufficiency in meat production;
- WHEREAS, in the exercise of Executive Power vested in the President by the Constitution of the Republic of Liberia, the President may issue Executive Orders in the public interest, either to meet emergencies or to correct particular situations which cannot await the lengthy legislative process to run its course,



4. NOW THEREFORE the Government hereby extends the moratorium placed under Executive Order No. 24, on import tariffs on the types of road construction equipment, forestry equipment, mining equipment, agricultural equipment, agricultural seeds, live animals for breeding and other goods directly related to agriculture development classified under the Tariff number of the Customs Revenue Code and Harmonized Description and Coding System of the Customs Tariff Schedules of Liberia Act 2000 attached to this Executive Order with immediate effect. Importers shall pay only the Customs User Fee (CUF) of 1.5 percent and the ECOWAS Trade Levy (ETL) of 0.5 percent where applicable. This moratorium shall expire a year from the effective date of this Executive Order or at the time the import tariff rates provided for in the revised Liberia Revenue Code shall be in effect.
