

The purpose of the Newsletter is to provide Acceding Governments a summary report of the meetings of the Informal Group on Accessions and to assist them with preparations for meetings and negotiations associated with their accessions. It is one of several practical steps by the WTO Secretariat to ensure transparency on accessions matters.

NEWSLETTER FOR ACCEDING GOVERNMENTS

The Fifth Meeting of the Informal Group on Accessions (IGA) took place yesterday, Thursday, 26 May 2011. At yesterday's meeting, the Secretariat consulted with Members on the evolving calendar of accessions meetings for 2011.¹ Nineteen delegations attended the meeting.

The Secretariat briefed the IGA on: (i) the progress of the seven 2011 Accession Priorities, namely, the three LDCs of Samoa, Vanuatu and Yemen; as well as Kazakhstan; Montenegro; the Russian Federation; and, Serbia; (ii) the recent developments in eight other active accession processes; (iii) the calendar of meetings; (iv) WP Chairmanships and appointments; and finally (v) technical assistance activities, capacity-building and outreach.

Members agreed with the proposed calendar of accession meetings (annexed). However, Members provided guidance that meetings could only go ahead on the basis of inputs received with sufficient time for consideration and review, normally a minimum period of 4 to 6 weeks.

Consensus is forming to designate Ambassador Francisco Pirez (Uruguay) as Chairperson of the Working Party on the Accession of Algeria. This would be announced at the next meeting of the General Council (27-28 July). Members were informed that the Chairmanships of two Accession Working Parties remained vacant (Iran and Uzbekistan).

The IGA was informed that: (i) the Regional Seminar on Accessions for the CEECAC Region would take place from 12 to 14 July 2011, in Vienna; and (ii) the Geneva-based Workshop would take place during the second half of 2011. Because of capacity constraints, Members were also informed that the Accessions Division was essentially declining requests for accession-specific national TA activities so as to focus on the substance of Working Parties. However, the Accessions Division would continue to organize periodic Accession Regional Workshops; the Geneva-based Seminar on Accessions for Acceding Governments; and, invest significant resources in the new accession platform established within the framework for "Geneva Week".
