FINAL WORKING PARTY MEETING ON THE ACCESSION OF YEMEN

The Eleventh and Final meeting of the Working Party on the Accession of Yemen took place on Thursday, 26 September 2013. Members of the WP adopted and recommended the Draft Accession Package of Yemen, ad referendum, to MC9 for formal action. Director-General Roberto Azevêdo welcomed the decision by the Working Party. In a meeting with Yemeni Trade Minister H.E. Dr Saadaldeen Talib, the Director-General confirmed WTO support for Yemen, including post-accession, as an LDC. Prior to the Final Working Party meeting, the Director-General met with the Delegation of Yemeni Parliamentarians. The adoption ad referendum of the draft Accession Package, on 26 September, was historic for Yemen as it was also a National Day.

Meeting with Yemeni Parliamentarians

The Director of the Accessions Division, Mr Chiedu Osakwe, chaired a working session with Yemeni Parliamentarians on 25 September 2013. At the session, the contents of the Draft Accession Package of Yemen were

explained. The Secretariat responded to questions from the Parliamentarians. The Director of Accessions confirmed the benefits of the Draft Accession Package for Yemen, with regard to creating: (i) conditions for enhanced competitiveness and attraction of investments; (ii) faster growth; (iii) a platform for continuing domestic reforms; (iv) improved governance; (v) trade integration with GCC and globally; and, (vi) the right to WTO Dispute Settlement and other benefits to pursue its development priorities.

The purpose of the Newsletter is to provide Acceding Governments with a summary report of the meetings of the Informal Group on Accessions and operationally relevant information to assist them with preparations for meetings and negotiations associated with their accession. It is one of several practical steps by the WTO Secretariat to ensure transparency on accessions matters. This document has been prepared under the Secretariat's own responsibility and without prejudice to the positions of Members and to their rights and obligations under the WTO.

FIRST GLOBAL SEMINAR ON WTO ACCESSIONS

The first Global Seminar on WTO Accessions took place from 23 to 27 September 2013. It was opened by Director-General Roberto Azevêdo.

In his opening remarks, Director-General Azevêdo underlined that the Global Seminar marked an important moment for the WTO, not only for accessions but also in the negotiations pillar for Bali. He stressed that Accessions remained a priority for WTO. He highlighted that since 1995, 31 countries have acceded, 6 of which were in the past 2 years.

He underlined that the accession process did not end in accession itself, and that the work continues for several years as acceding Governments continue their post-accession adjustments.

The Global Seminar was jointly organized by the Accessions Division and the Institute of Training and Technical Cooperation. Participants included 17 officials from Acceding Governments, Accessions Working Party Chairpersons, a range of WTO and Members Representatives of International Organizations. The purpose of the Global Seminar was to (i) take stock of the acquis from 31 accessions concluded since 1995; (ii) review lessons learned from concluded accessions: (iii) reflect on the directions in which the results of the ratified and deposited protocols were pointing the Trading System; and, (iv) initiate an assessment of how well Accession results were serving the Trading System and the Global economy.

The different sessions of the Global Seminar were covered by representatives of Member States and the Secretariat and revolved around: (i) the mandate, policy framework and best practices of concluded accessions and the challenges for the future; (ii) rule-making in the WTO, fine-tuning and evolution through accessions and jurisprudence; (iii) description of the multilateral and bilateral any accession process WTO Secretariat; (iv) technical analysis of the components of the multilateral track of an accession process by representatives of Member States; (v) experience sharing of the bilateral track of an accession process by representative of Members States; (vi) Agriculture; (vii) Accessionrelated Capacity Building and Outreach; (viii) Roundtable on the role of the WP Chairperson and on the experiences of Chief Negotiators.

The Sessions offered an opportunity for Members and officials from Acceding Governments to exchange views and experiences on Accessions and a broad range of WTO-related issues.
