

# **WTO Accessions Newsletter**

...safeguarding and strengthening the rules-based multilateral trading system

#### **IGA-AGENDA:**

The First meeting of the Informal Group on Accessions (IGA) in 2014 took place today, 30 January. The meeting was chaired by the Director of the Accessions Division. Members of the IGA were briefed on: (i) LDCs accession negotiations and developments in respect of several Article XII LDCs; (ii) active non-LDCs' accession negotiations; (iii) accession WPs under "maintenance"; and, (iv) accession-specific technical assistance and capacity-building. The WTO Secretariat consulted IGA Members on the updated ECAM: Evolving Calendar of Accessions Meetings for the first quarter of 2014 (annexed). The IGA was informed of the re-composition of Secretariat Accession Working Party Teams (annexed).

#### **ACCESSIONS OF LEAST-DEVELOPED COUNTRIES**

The IGA was informed that accessions remained an area of strategic priority for the Director-General Azevêdo. Secretariat resources were allocated to reflect the priority attached by the WTO to LDCs' accessions. In its updated report to the IGA, the Secretariat recalled that seven LDCs had acceded to the WTO since 1995 and eight were in the process of negotiating the terms of their WTO Membership. Of these eight, the state-of-play showed that: Afghanistan was technically maturing and was advancing towards its endgame stage and conclusion; Liberia was building up its technical capacity and was in regular technical exchange with the Secretariat regarding the preparation of inputs for the next meeting of its Working Party; Equatorial Guinea and Sao Tomé e Principe had neither submitted Memoranda on their Foreign Trade Regimes, nor initial market access offers; and, Sao Tomé and Principe was under Category III of Administrative Measures; Comoros had submitted its MFTR, although initial market access offers were still awaited; Ethiopia reflected no activity since July 2012; and, Bhutan and Sudan were dormant. The Secretariat continued to monitor the post-accession situation of Article XII LDCs. So far, the overall effects of domestic-reforms associated with their accession terms pointed to positive effects on their economies. Cape Verde that had acceded as an LDC had graduated. Samoa had graduated on 1 January 2014. Vanuatu was in the graduation gueue. Graduation was a positive economic signal and was to be supported and not resisted.

The IGA welcomed the approval of Yemen's WTO membership at the MC9 in Bali. It appreciated the Secretariat's report that Afghanistan's accession was on a firm track for a 2014 completion. It was reiterated that the priority attached to LDCs' accessions would continue.

#### 2014 ACCESSION WP FOCUS

Afghanistan: The accession of Afghanistan had significantly advanced and was technically maturing. It was advancing to its endgame and final stage. All bilateral market access negotiations had been concluded. The official signing of several bilateral agreements was scheduled for mid-February. The had initiated the Secretariat process consolidating the deposited bilateral agreements to generate the Draft Schedules of Commitments on Goods and Services, which would be circulated to signatory Members for verification. The Draft Working Party Report (DWPR) was approaching its final version with only a few issues outstanding. Critical decisions were expected to be taken by Afghanistan soon on a limited range of issues relating to: customs, its fixed tax, the investment regime and IPRs protection. A revised DWPR would be circulated to Members, shortly. The delegation of Afghanistan would be in Geneva in February to work with Members and the Secretariat on the remaining aspects of its Draft Accession Package. The next cycle of meetings was envisaged for March 2014.

<u>Azerbaijan</u>: All inputs for the Working Party, including the revised DWPR, had been circulated in 2013. The next cycle of meetings, postponed at the request of Members due to the Bali Ministerial Conference, was now envisaged for 20-21 February.

Bosnia and Herzegovina: This accession was advancing to its final stages. Most bilateral market access negotiations had been concluded. Two bilateral market access agreements (with Ecuador and Panama) had been signed and deposited with the WTO Secretariat. On the multilateral track, additional outstanding work included the adoption of pending bills and the submission of an updated, final version of the Legislative Action Plan (LAP). The ball was in the court of Bosnia and Herzegovina regarding decisions that would enable the conclusion of its accession, as soon as possible.

Kazakhstan: This was an advanced accession, although challenging and complex with a set of unresolved and outstanding questions. The major challenge revolved around the question of tariff adjustment, which was unique in accession negotiations, so far. outstanding issues included, agriculture, SPS, TRIMs, STEs, Headnotes to the Draft Goods Schedule, etc. The Secretariat had received responses and feedback from Kazakhstan to several questions from WP Members. Other answers were still awaited. On services, Astana continued to review the Draft Consolidated Services Schedule in consultation with Signatory Members. A technical verification meeting would be convened by the Secretariat, in accordance with standard practice, after Kazakhstan re-submits the Draft Services Schedule to the Secretariat. The timing of the next cycle of meetings would depend on the resolution of a critical proportion of outstanding questions. Meanwhile, the Delegation of Kazakhstan was in contact with Members. No specific date was yet envisaged for the next cycle.

<u>Serbia:</u> This accession was at an advanced stage. Progress towards closure was subject to the enactment of outstanding WTO-consistent GMO legislation and conclusion of outstanding bilateral market access negotiations.

<u>Seychelles:</u> This accession was progressing. Two bilateral agreements on market access had been signed with Thailand and Japan. Seychelles was preparing its replies to questions and comments, submitted by Members. Technical assistance had been requested in the areas of: SPS, TBT, IPR and legal drafting. The Secretariat in coordination with other TA providers would provide accession-specific TA in these areas in the period from February to April.

Bahamas: Nassau was reviewing the draft Factual Summary prepared by the Secretariat. margins of the 9<sup>th</sup> WTO Ministerial Conference in Bali, Minister Pinder of the Bahamas had reaffirmed the commitment of Nassau to complete its accession negotiations, as early as possible. Technical assistance had been requested in several areas, including import licensing; TRQs; rules of origin; intellectual property protection; establishment of a standards bureau. The Secretariat was consulting with Nassau on an awareness-building programme on WTO membership and adjustment issues that are entailed in WTO membership. WTO Director-General David Shark was in conversation with Nassau regarding such an activity. Documentary inputs from Nassau were awaited before the next cycle of meetings of the WP could be convened.

## MAINTENANCE WORK

The IGA was briefed on the progress in 4 other active accessions:

Algeria: This accession was progressing. The Algerian negotiating team was actively engaged. In 2013, the Secretariat had circulated the Q&A document, legislation notices and the Revised Goods and Services Offers submitted by Algiers. The Secretariat had forwarded the updated DWPR to Algiers for technical comments and factual updates, December 2013. The Secretariat was in technical exchange with Algeria to process the inputs that had been received so far. The submission of a revised LAP and its accompanying draft and enacted legislation; as well as the Questionnaire on Statetrading Enterprises, remained outstanding. In Bali, Ambassador D'Alotto (Argentina), WP Chairperson, held a bilateral meeting with the Algerian Delegation to review issues essential for continued progress on the Accession of Algeria. The next cycle of meetings was envisaged for end-March 2014, if all required negotiating materials were available.

<u>Belarus</u>: In October/November 2013, Minsk had circulated several required negotiating materials: a revised LAP, revised SPS/TBT checklists, replies to Members' questions, updated information on the implementation of the CVA and TRIPS, a revised Questionnaire on ILPs. Several bills and the revised Services and Goods Offers were still outstanding. No WP cycle of meetings was envisaged at this time.

<u>Comoros</u>: The Memorandum of Foreign Trade Regime had been circulated in October 2013. The deadline for the submission of comments and questions had been set for 31 January 2014. In Bali, the Secretariat met with the Minister of Commerce of Comoros. Comoros was encouraged to submit, as soon as possible, its initial market access offers on goods and services, a LAP and any request for technical assistance.

<u>Liberia</u>: In Bali, the WP Chairperson, Ambassador Joakim Reiter (Sweden), Arancha Gonzalez, ITC Executive Director and the Director of the Accessions Division met with the Liberian Minister of Commerce and Industry. It was agreed that the Secretariat would design a joint capacity building workshop to improve the Liberian officials' understanding of WTO rules and strengthen their capacity to prepare negotiating materials for the WP. In collaboration with the Swedish National Board of Trade, the WTO Secretariat was designing an accession-specific activity. An intern from Liberia would be financed from the China Programme.

#### **OUTREACH AND TECHNICAL ASSISTANCE**

The IGA was briefed on technical assistance and capacity-building activities underway. Specific to assistance preceding this First IGA, the Secretariat conveyed its appreciation to IGA Members, in particular China, EU and the US. Members were urged to sustain this assistance. Accession-specific support from the International Trade Center was acknowledged.
