

**GOVERNMENT OF THE RUSSIAN FEDERATION**

**RESOLUTION NO. 310  
OF MAY 26, 2006**

**ON REQUISITIONING OF ANIMALS AND LIVESTOCK PRODUCTS TO  
LIQUIDATE HOTBEDS OF VERY DANGEROUS ANIMAL DISEASES**

For the purpose of preventing and liquidating animal diseases and ensuring veterinary safety of livestock products and pursuant to the law of the Russian Federation On Veterinary Service the Government of the Russian Federation hereby resolves:

1. To approve the attached Rules of Requisitioning of Animals and Livestock Products to Liquidate Hotbeds of Very Dangerous Animal Diseases.

2. The Agriculture Ministry of the Russian Federation shall:

within 10 days approve the list of diseases which can be grounds for requisitioning of animals and livestock products determined by the Federal Veterinary and Phyto-Sanitary Supervision Service;

develop and bring to the knowledge of the subjects of the Russian Federation the recommendations on the organization and conduct of requisitioning of animals and livestock products during the liquidation of hotbeds of very dangerous animal diseases.

**RULES OF REQUISITIONING OF ANIMALS  
AND LIVESTOCK PRODUCTS  
TO LIQUIDATE HOTBEDS OF VERY  
DANGEROUS ANIMAL DISEASES**

1. These Rules shall regulate the relations in the process of requisitioning of animals and livestock products for the purpose of preventing the emergence of and liquidating hotbeds of very dangerous animal diseases as well as of preventing the spread of the causes of contagious diseases of animals and protecting the population against diseases that are common to humans and animals.

2. These Rules shall be binding on citizens, legal entities, state power bodies of the Russian Federation, state power bodies of the subjects of the Russian Federation and local government bodies during activities to prevent the emergence of and to liquidate the hotbeds of very dangerous animal diseases.

3. Animals and livestock products may be requisitioned to prevent the emergence of and liquidate the hotbeds of very dangerous animal diseases as per the list of diseases that may be grounds for requisitioning of animals and livestock products approved by the Ministry of Agriculture of the Russian Federation.

4. The officials of the State Veterinary Service and veterinary experts in identifying the animals that carry agents of the diseases included in the list referred to in Section 3 of these Rules, or animals with clinical signs of such diseases shall promptly send a written notification to the effect to the State Veterinary Inspector for a particular area and to the Chief State Veterinary Inspector of the subject of the Russian Federation.

5. The State Veterinary Inspector for a specified area, upon receiving the information referred to in Section 4 of these Rules, shall file a request with the local government body for restrictive measures, including quarantine, of a form approved by the Federal Veterinary and Phyto-Sanitary Supervision Service.

6. The Chief State Veterinary Inspector of the subject of the Russian Federation, upon receiving the information referred to in Section 4 of these Rules, shall promptly send a written notification about the emergence of very dangerous animal diseases in the area under his jurisdiction to the territorial body of the Federal Veterinary and Phyto-Sanitary Supervision Service.

7. The head of the territorial body of the Federal Veterinary and Phyto-Sanitary Supervision Service or his deputy (in accordance with the distribution of duties) shall within 2 days of receiving the information referred to in Section 6 hereunder, make a decision on the need to conduct requisitioning of animals and livestock products to liquidate the hotbeds of very dangerous animal diseases of a form contained in Annex No.1.

Such decision shall be sent to the Chief State Veterinary Inspector of the subject of the Russian Federation, the State Veterinary Inspector of an area, as well

as for the purpose of making a decision on requisitioning of animals and livestock products, to the chief executive of the subject of the Russian Federation.

The executive state power body of the subject of the Russian Federation which has decided to organize and conduct requisitioning of animals and livestock products shall send a copy of the decision taken to the citizens and legal entities – owners of animals and livestock subject to requisitioning.

8. The requisitioning of animals and livestock products for the purpose of preventing the emergence of and liquidating hotbeds of very dangerous animal diseases shall be organized and conducted under a procedure established by the subject of the Russian Federation concerned.

During the requisitioning of animals and livestock products a statement shall be drawn up on the requisitioning of animals and livestock produces for the purpose of liquidating hotbeds of very dangerous animal diseases of a form contained in Annex No.2.

9. Citizens and legal entities are entitled to compensation of the damage they have sustained as a result of the requisitioning of animals or livestock products in the amount of the value of the requisitioned animals or livestock products in accordance with the procedure of the spending of budgetary assets of the subject of the Russian Federation allocated for such purposes.

10. Grounds for compensation for the damages sustained by citizens and legal entities as a result of the requisitioning of animals or livestock products shall be the statement referred to in Section 8 hereunder, and copies of a decision of the chief executive of the relevant subject of the Russian Federation on organizing and conducting requisitioning of animals and livestock products.

11. The extent of the compensated damage sustained by citizens and legal entities as a result of requisitioning of animals or livestock products shall be determined by the subject of the Russian Federation on the basis of state-regulated prices if such prices have been fixed. In all other cases the size of the said damage shall be determined on the basis of the market value of requisitioned animals and livestock products.

12. Citizens and legal entities – owners of animals and livestock products subject to requisitioning shall:

render assistance in the conduct of requisitioning of animals and livestock products:

in the event their rights are violated in the process of requisitioning of animals and livestock products they shall have the right to appeal against the actions of officials under a procedure set by the legislation of the Russian Federation.

13. Compliance with the decision of the chief executive of the subject of the Russian Federation on requisitioning of animals and livestock products shall be ensured by the territorial bodies of the Federal Veterinary and Phyto-Sanitary Supervision Service.
