

**I. AGREEMENT THE USE OF SINGLE A SINGLE MARK OF TURNOVER OF PRODUCTS ON THE MARKET OF THE MEMBER STATES OF THE EURASIAN ECONOMIC COMMUNITY**

Governments of the Member States of the Eurasian Economic Community (hereinafter - the Eurasian Economic Community), hereinafter referred to as the Parties,

Guided by the Treaty on Customs Union and Common Economic Space of 26 February 1999 and the Treaty establishing the Eurasian Economic Community on 10 October 2000,

Striving to eliminate unnecessary restrictions in mutual trade,

Considering their mutual interest in ensuring the safety and quality of imported products for the life and health, environmental protection

agreed as follows:

**Article 1**

For the purposes of this Agreement, the concepts used are as follows:

"Single mark of turnover on the market of EurAsEC member states", "single mark of turnover" - a designation serves to inform purchasers on conformity of manufactured products in the treatment of the technical regulations EEC;

"conformity confirmation" - a documentary certification of compliance with product requirements of technical regulations EEC;

"Products" - the result of the activities presented in material form and intended for further use in commercial and other purposes;

"Technical regulation of the EurAsEC," - a document adopted in the framework of the EurAsEC and establishing mandatory for the application and enforcement of product requirements.

**Article 2**

Single mark of turnover of products on the market of the Member States of the Eurasian Economic Community is applied to labeling of products to meet the requirements of technical regulations of the EurAsEC.

**Article 3**

The shape and size of a Single mark of turnover and order of marking of products are provided in the Order on a Single mark of turnover products on the market of the EurAsEC member states, which is approved by the Interstate Council of EurAsEC (at the level of Heads of Government).

**Article 4**

Products marked with a Single mark of turnover are allowed to the territories of the EurAsEC member states without re-registration documents for confirmation of conformity issued in accordance with legislation of the EurAsEC member states, from which the products are in

circulation (on sale).

#### **Article 5**

This Agreement shall not affect the application of sanitary, veterinary and phytosanitary measures for import (export) of goods to / from the territory of the EurAsEC member states.

#### **Article 6**

Compliance with technical regulations EurAsEC products, be marked by a Single mark of turnover should be confirmed in the manner prescribed by the legislation of the State - a member of the EurAsEC, in which it is made.

#### **Article 7**

The competent authorities of the Parties inform each other about the revealed violations encountered in the implementation of this Agreement and shall take measures in accordance with their national legislation in case of detection of nonconforming product, display a Single mark of turnover requirements of technical regulations of the EurAsEC.

Responsibility for labeling of products is one sign of circulation manufacturer (supplier) product.

#### **Article 8**

Disputes concerning the application or interpretation of the provisions of this Agreement shall be settled through consultations and negotiations between the Parties.

#### **Article 9**

By agreement of the Parties to this Agreement may be amended in the form of separate protocols.

#### **Article 10**

Any Party may withdraw from this Agreement by written notification to the depositary. This Agreement shall for that Party shall expire 6 months from the date of receipt by the Depositary of the notification.

Depositary of this Agreement is the Integration Committee of EurAsEC.

#### **Article 11**

This Agreement shall enter into force on the date of receipt by the depositary of the fifth written notification of the Parties to the internal procedures required for its entry into force.

Done at Minsk on 19 May 2006 in one original copy in Russian. The original copy is stored in the EurAsEC Integration Committee, which shall send to each Party a certified copy.
