#### RESOLUTION

### OF THE GOVERNMENT OF THE REPUBLIC OF TAJIKISTAN

# "ON THE LIST OF PRODUCTS (WORKS, SERVICES" SUBJECT TO THE MANDATORY CERTIFICATION

In accordance with the Article 8 of the Law of the Republic of Tajikistan on "Consumers rights protection", the Government of the Republic of Tajikistan decrees the following:

- 1. Approve the List of products (works, services) subject to mandatory certification (to be attached).
- 2. Entrust the Agency on standardization, metrology, certification and trade inspection under the Government of the Republic of Tajikistan the coordination of activity of the bodies responsible for control over safety of goods (works, services).
- 3. Authorize the Agency on standardization, metrology, certification and trade inspection under the Government of the Republic of Tajikistan to be responsible for organization and implementation of activities related to mandatory conformity of goods (works, services) with set requirements.
- 4. Agency on standardization, metrology, certification and trade inspection under the Government of the Republic of Tajikistan shall be responsible for informing the Customs Service under the Government of the Republic of Tajikistan about existing, newly established accreditation bodies on certification of the homogeneous products in the National Certification System of the Republic of Tajikistan based on the relevant group of products with an indication of the list of goods related to their sphere of accreditation.
- 5. The Customs Service under the Government of the Republic of Tajikistan shall admit the products subject to mandatory certification in accordance with this List to the customs territory of the Republic of Tajikistan given that the conformity certificate has been provided, which has a single form for all certification bodies and which has been developed and approved by the Agency on standardization, metrology, certification and trade inspection under the Government of the Republic of Tajikistan. When filling out the procedures of customs one shall follow the instructions of this List.
- 6. Agency on standardization, metrology, certification and trade inspection under the Government of the Republic of Tajikistan shall, in an established manner, make the proposals on amending the list of goods (works, services) subject to mandatory certification to the Government of the Republic of Tajikistan.
