On the Enhancement of Promotion of Domestically Manufactured Goods in International Markets

In order to use the export potential effectively, and to enhance the competitiveness of domestic production, as well as to protect the domestic market of The Republic of Tajikistan, The Government of The Republic of Tajikistan orders:

- 1. The Ministry of Economy and Trade of The Republic of Tajikistan and the Tajik Universal Commodity Exchange to make short term and long term forecasts of the market for manufactured goods, which comprise an export potential for The Republic.
- 2. The Tajik Universal Commodity Exchange, on the basis of bilateral agreements, shall provide producers with marketing information and analytical services to promote the sale of their products and raw materials.
- 3. Products manufactured in The Republic by organizations and other entities, regardless of the legal status, and raw materials, shall be exported through the Tajik Universal Commodity Exchange, in accordance with its standards and samples. Cotton and cotton products for the domestic market shall also be sold through the Tajik Universal Commodity Exchange.
- 4. To adopt the list of products and raw materials, according to the CCFEA CIS, which are to be sold in sales and auctions of the Commodity Exchange, according to the regulations in Appendix 1 of this document.

To establish that the commission premium in the Commodity Exchange is as follows:

 \bullet 0.1% of the cost of the contract or the deal for the sale or purchase of an agricultural raw material or product

• 0.1% of the cost of the contract or the deal for the sale or purchase of industrial and technical types of raw materials, goods and products.

- 5. The Customs Committee of The Republic of Tajikistan shall prepare customs documentation for the export of the products listed in clause 4 of the present Decree, following submission in each case of a Commodity Exchange Official Contract, and Certificate from the Exchange.
- 6. The Customs Committee of The Government of The Republic of Tajikistan and the Commodity Exchange shall report monthly, to the Ministry of Economy and Trade of The Republic of Tajikistan, on the export-import operations of the trading entities, and the terms of their contracts, in order to make an analysis and summary.
- 7. The Ministry of Economy and Trade of The Republic of Tajikistan shall conduct a monthly analysis of the effectiveness of the performance of contracts (agreements) of the exportimport operations of the trading entities, and on the adverse economic effects on the interests of The State due to their trading activities, and shall submit proposals to The Government of The Republic of Tajikistan.
- 8. To cancel the Decree of The Government of The Republic of Tajikistan of the 21st of October 1997, N 468 "On measures on enhancement of payments of fees for services for

export production documentation provision" the Decree by The Government of The Republic of Tajikistan of the 15th of July, 2000 N 244-14 and the Decree by the Government of The Republic of Tajikistan of the 16th of December 1997 N 514-20
