ON AMENDMENT OF THE RULES OF VEHICLES IMPORTATION INTO UKRAINE

The Cabinet of Ministers of Ukraine herewith **r** e s o l v e s:

- 1. To enter amendments (as attached) to the Rules of Vehicles Importation into Ukraine as approved under Resolution #341 of the Cabinet of Ministers of Ukraine of 31 May 1994 (*ZP Ukrayiny*, 1994, N 9, p. 227; 1995., N 4, p. 109; *Ofitsiyinyi Visnyk Ukrayiny*, 1998, N 27, p. 996; 2000., N 6, p. 211; 2002., N 45, p. 2068; 2004., N 11, p. 669).
- 2. To invalidate the following resolutions:

Resolution #218 of the Cabinet of Ministers of Ukraine of 4 February 2000 On Amendments to Resolution #341 of the Cabinet of Ministers of Ukraine of 31 May 1994, N 341 (*Ofitsiyinyi Visnyk Ukrayiny*, 2000, N 6, p. 211);

1. AMENDMENTS Entered into the Rules of Vehicles Importation into Ukraine

2004

- 1. Clause 7 of these Rules shall read as follows:
- "7. Importation into Ukraine with the view of further operation or dismantlement into parts of the following items shall be prohibited:
- 1) of buses (UKTZED Code 8702) and trucks (UKTZED Code 8704) which, as at the time of their importation, had been produced 5 and more years ago and/or had been in operation for more than 5 years;
- 2) other mechanical means of transportation which, as at the time of their importation, had been manufactured 8 and more years ago, excluding for:

importation of tram cars with the gauge of 1,000 mm not produced in Ukraine;

importation of vehicles by citizens entering into Ukraine for permanent residence

importation (obtaining) of vehicles by citizens permanently residing in Ukraine as heritage;

importation of vehicles in compliance with international agreements of Ukraine including items imported as part of technical assistance;

importation of vehicles as collectable items (antique and those having artistic, historic or other value) subject to conclusions (permits) of the Ministry of Transportation and Communication as approved by the Ministry of Culture;

importation for permanent use of mechanical means of transportation whose technical condition meets requirements of rules and standards pertaining to ensuring traffic and environmental safety (save for tram cars and trolleybuses and their bodies) subject to a permit issued by the Ministry of Transportation and Communication, while in the case of tram cars and trolleybuses and their bodies – subject to a permit issued by the State Committee for Housing and Communal Services following the procedure established by said organizations inasmuch as the vehicles in question:

- a) are recognized by a Commission for Humanitarian Assistance of the Cabinet of Ministers of Ukraine as humanitarian assistance;
- b) have been duly detained and seized by customs authorities;
- c) are kept in the custom's custody and the owner has not applied for them until the expiration of their storage period"".

2. To supplement the Rules with Paragraph 7¹ reading as follows:

"7¹. Importation into Ukraine for the purposes of permanent use of mechanical means of transportation manufactured 8 and more years ago in cases not covered by clause 2 of paragraph 7 shall be performed subject to a relevant decision of the Cabinet of Ministers of Ukraine".
