

THE LAW OF UKRAINE

On Amending the Law of Ukraine “On Export Duty for Live Bovine Animals and Leather Raw Materials”

The Verkhovna Rada of Ukraine hereby decrees to:

I. Make amendments to the Law of Ukraine “On Export Duty for Live Bovine Animals and Leather Raw Materials” (Vidomosti Verkhovnoyi Rady of Ukraine, 1996, No.28, p.133) and state it in the following wording:

“The Law of Ukraine

On Export Duty for Live Bovine Animals and Leather Raw Materials

With the purpose of protection of the domestic consumer market of Ukraine, interests of home producers and further improvement of the export structure of Ukraine the Verkhovna Rada of Ukraine hereby decrees:

1. Establish the following export duty rates for live bovine animals and leather raw materials:

4101	Raw hides and skins of bovine or equine animals (fresh, or salted, dried, limed, pickled or otherwise preserved, but not tanned, parchment-dressed or further prepared), whether or not dehaired or split	15
4102	Raw skins of sheep or lambs (fresh, or salted, dried, limed, pickled or otherwise preserved, but not tanned, parchment-dressed or further prepared), whether or not with wool on or split, other than those excluded by note 1 (c) to this chapter:	15

Starting from January 1, 2007 the export duty rate for goods of codes according to UCG FEA 4101, 4102, 4103900000 shall be annually decreased by 1 percentage point down to the value of 10 per cent.

2. The specially authorized central executive authority for economic policy shall quarterly establish indicative prices for live bovine animals and leather raw materials, the types of which are specified in this Law, in consideration of the level of prices of sale of such goods at the world market, and publish them at least 30 calendar days prior to application. Indicative prices established by the specially authorized central executive authority for economic policy shall be mandatory for agents of foreign economic activity of all ownership forms while entering into and fulfillment of foreign economic agreements (contracts)".

II. The Law shall take legal effect on January 1, 2006.
