

THE LAW OF UKRAINE

No. 356-V of 16 November 2006

On Amending the Law of Ukraine “On Export Duty for Live Cattle and Leather Raw Materials”

The Verkhovna Rada of Ukraine hereby decrees:

I. The Law of Ukraine “On Export Duty for Live Cattle and Leather Raw Materials” (Vidomosti Verkhovnoyi Rady Ukrainy, 1996, No. 28, p. 133), shall read as follows:

“The Law of Ukraine

On Export Duty for Live Cattle and Leather Raw Materials

To approve the following export duty rates for goods exported outside Ukraine:

Starting January 1 of the year following the year of Ukraine's accession to the full membership of the World Trade Organization:

the export duty rate for products under codes according to UPC FEA 0102 90 05 00, 0102 90 21 00, 0102 90 29 00, 0102 90 41 00, 0102 90 49 00, 0102 90 51 00, 0102 90 59 00, 0102 90 61 00, 0102 90 69 00, 0102 90 71 00, 0102 90 79 00, 0102 90 90 00, 0104 10 10 00, 0104 10 30 00, 0104 10 80 00 shall be annually decreased by five percentage points down to the value of 10 percent.

the export duty rate for products under codes according to UPC FEA 4101, 4102, 4103 90 00 00 shall be annually decreased by one percentage point down to the value of 20 per cent".

II. This Law shall take legal effect on the date of Ukraine's accession to the World Trade Organization.
