**ON MAKING CHANGES TO IMPORT DUTY RATES FOR CERTAIN GOODS AND TO
CERTAIN DECISIONS OF THE
GOVERNMENT OF UKRAINE**

The Cabinet of Ministers of Ukraine orders:

1. To make changes to import duty rates for certain goods according to the Appendix.
2. In the Appendix to the Resolution of the Cabinet of Ministers of Ukraine of May 3, 1994 No 285 "On the Introduction of Changes to Import Duty Rates for Certain Goods" (SP of Ukraine, 1994, No 11, article 266) types of goods, codes 2.08 10900 (only for positions 87.02 - 87.05), 57.01 - 57.03, shall be excluded. Similarly in the Appendix to the Resolution of the Cabinet of Ministers of Ukraine of July 18, 1995 No. 531 "On Making Changes to Import Duty Rates for Certain Goods and to Certain Decisions of the Government of Ukraine" a type of good, code 84.07 33100, shall be excluded.
