

**On Modifications to the Import Duty Rates  
for Certain Types of Goods.**

**Resolution of January 27 1997, No. 67**

The Cabinet of Ministers of Ukraine **RESOLVES** on the following:

1. To implement modifications to import duty rates for certain types of goods according to the annex.

2. To exclude the following types of goods: Annex to the Resolution of the Cabinet of Ministers of Ukraine of May 3, 1994 No. 285 "On Modifications to the Import Duty Rates for Some Types of Goods" (ZP of Ukraine, 1994, No. 11, Art.266), codes 39.14 00000, 84.24 20900, Annex to the Resolution of the Cabinet of Ministers of Ukraine of July 20, 1996 No. 770 "On Modifications to the Import Duty Rates for Some Types of Goods", code 33.02 90000, Annex to the Resolution of the Cabinet of Ministers of Ukraine of November 8, 1996 No. 1376 "On Modifications to the Import Duty Rates for Some Types of Goods", code 34.02 20900, 34.02 90900.
