On Approval of the List of Industrial-Purpose Goods Which may not be Exported from the Customs Territory of Ukraine by Ukrainian Nationals, Foreigners or Stateless Persons

As amended by Cabinet of Ministers Resolution No.92 of 18 January 2003

In accordance with Article 251 of Ukraine's Customs Code, the Cabinet of Ministers of Ukraine **resolves:**

1. To approve the list of industrial-purpose goods which may not be exported from the Customs territory of Ukraine by Ukrainian nationals, foreigners or stateless persons (the list enclosed).
2. To repeal Resolutions of Cabinet of Ministers of Ukraine as listed in the enclosure.
3. That this Resolution come into force on 1 January 2004 (Clause 4 as amended by the Cabinet of Ministers' Resolution No.92 of 18 January 2003)
