Order

of the State Department for Veterinary Medicine dated September 27, 2002 No.52

On Amendments to Veterinary Requirements for Imports into Ukraine of Cargoes subject to Control by the Service of State Veterinary Medicine

In order to implement Articles 3, 12 and 17 of the Law of Ukraine "On Veterinary Medicine", the Regulation on Regional Service of State Veterinary Control at the State Border and Transport approved by the Resolution of the Cabinet of Ministers No.264 of March 2, 1998, and in order to strengthen control over protections of the territory of Ukraine against the bringing in of agents of quarantine disease, common for people and animals, from territories of other countries or quarantine zones, as well as in connection with the harmonization of national legislation of Ukraine with Article 51 of the Agreement on Cooperation between Ukraine and the European Communities

I ORDER:

- 1. To introduce changes into the Veterinary Requirements with regard to imports into Ukraine of cargoes subject to control by the Service of State Veterinary Medicine, approved by the Order of the Main State Officer of Veterinary Medicine of Ukraine No39 of October 20, 1999 and registered at the Ministry of Justice of Ukraine, No.777/4070 of November 11, (with changes and amendments), namely:
- 1.1. In the title of Veterinary Requirements to replace the words "cargoes subject to control by the Service of State Veterinary Medicine" by words "objects of the State veterinary and sanitary control and supervision".
- 1.2. To supplement Paragraph 3 of the Item 1.1 after words "African hog cholera" with words "objects of the State veterinary and sanitary control and supervision".
- 1.3. To exclude words "cattle-plague, contagious pleuropneumonia" from paragraph 4 of the Item 1.1.
 - 1.4. In Items 2.2, 3.3, 19.1:

to exclude the third paragraph;

to supplement paragraph 4 after words "of the foot-and-mouth disease" with the words "African hog cholera".

1.5. In Item 4.1:

to supplement Paragraph 3 after words "African hog cholera" with words "plague, contagious pleuropneumonia of the cattle";

To exclude words "plague, contagious pleuropneumonia of the cattle" from Paragraph 4 after words "foot-and-mouth disease".

1.6. In Item 5.1:

To supplement paragraph 3 after words "African hog cholera" with words "infectious pleuropneumonia, sheep and goat pox";

To delete in paragraph 7 the words "infectious pleuropneumonia", "and sheep and goat pox".

1.7. In Item 6.2:

to delete in paragraph 3 the words "African hog cholera";

to supplement paragraph 4, after the word "Q fever", with the words "African hog cholera";

to delete paragraph 5.

- 1.8. To supplement paragraph 1 in Item 10.1, after the words "African horse cholera", with the word "leptospirosis".
- 1.9. To supplement Items 10.2, 11.2, 12.5, after the words "virus arteritis", with the word "leptospirosis".

1.10. In Item 12.2:

to delete the words "African hog cholera" in paragraph 2;

to supplement paragraph 4, after the words "of the foot-and-mouth disease", with the words "African hog cholera".

1.11. In Item 14.1:

to delete paragraph 2;

to supplement paragraph 3, after the word "of the foot-and-mouth disease", with the words "African hog cholera".

- 1.12. To replace in paragraph 3 of sub-item "a" of Item 15.1 the words "within the territory of the country" with the words "within the administrative territory".
- 1.13. To replace the words "within the territory of the country" respectively with the words "within the administrative territory" in paragraphs 2 and 3 of Items 17.1 and 18.1 and in paragraph 3 of Item 27.2.
- 1.14. To supplement 22.1 with the following paragraph: "It shall be permitted to import sub-products only for production processing with the designation of a particular meat-processing enterprise".
- 1.15. To delete the words "as well as sub-products" in paragraph 11 of Item 22.4.

1.16. In sub-item "a" of Item 23.4:

to delete paragraph 1;

to supplement paragraph 2, after the words "of the foot-and-mouth disease", with the words "African hog cholera".

- 1.17. To replace the words "in the country" with the words "within the administrative territory" in paragraph 3 of Item 24.4.
- 2. The Division of the State Veterinary Medicine Inspectorate within the State Department for Veterinary Medicine of the Ministry of Agrarian Policy of Ukraine (M. V. Patsiuk):
- 2.1. must furnish within a 5-day period this Order to the Ministry of Justice of Ukraine for State registration.
- 2.2. must make this Order known to all heads of State Veterinary Medicine Divisions of the Autonomous Crimean Republic, oblast State Administrations, the cities of Kyiv and Sevastopol, regional Veterinary Control Services at the State border and on transport.
- 3. I retain control over implementation of the Order.
