1. The “why”: why the period 2008-2017?

- ❖ **We started from the year 2008** because that is the first year of the Evolving Table as a WTO document in the series WT/CFMC/6/*.
- ❖ Over the years, however, the evolving table has undergone **a number of changes** in terms of structure and information reported, for example:
 - ✓ The Annexes listing completed projects have been created in July 2011 on the basis of information listed elsewhere in the Table.
 - ✓ A section of the Table containing “available resources” has been deleted as of November 2016.




The “what”: Geographical distribution of projects

Total number of active and completed projects




 Countries with active projects (2017)



The “what”: snapshot on active projects in November 2017 (WT/CFMC/6/Rev.23 – cotton specific)


Ongoing projects in Africa and the rest of the world, 2017
