Session Title

Sustainable Stock Exchanges: Stock Exchanges and climate action – financing the net zero transition

Session Description

Since the historic COP21 in Paris, the UN SSE programme, jointly organized by UNCTAD-DIAE, UN Global Compact, UNPRI and UNEP-FI has held a high-level CEO – Policy Maker dialogue at every COP on the role of stock exchanges in accelerating climate finance and corporate climate disclosure. This COP27 session, co-organized with IOSCO, will bring together CEOs of stock exchanges, Chief Security Market Regulators, and leading standard setters, along with key development partners (e.g. IFC -World Bank) to build consensus on further action to promote the adoption and implementation of global climate disclosure standards and the further innovation of credible and impactful climate finance instruments. The dialogue will feature the sharing of experiences from different markets to inspire all market leaders and promote the sharing of best practices. The dialogue between market infrastructure operators and market regulators seeks to identify opportunities for policy/regulatory innovation to further support the development of climate finance. It will also support the Glasgow Financial Alliance for Net Zero (GFANZ) launched at COP26, with the announcement of new members of the Net Zero Exchange Group, a group of stock exchanges committed to promote net zero emissions and target setting in their markets. This event is part of a long-standing series of meetings at COPs between security market regulators and CEOs of stock exchanges. It is a specialized community focused on capital market finance. As such, this session will not compete with the BICFIT launch. In COP28 in Dubai, this session was held at the same time that the main Trade Day Events, which were held in the COP28 Presidency stage.
