



 Since February 2024: 15 TPRs, containing 46 questions related to fossil fuel subsidies and FFS reform



- Mining and Energy price control for petroleum products
- Energy crisis: temporary measures
- Identification of existing price support mechanisms
- Economic, social and environmental impact analysis
- Participation in FFSR discussions
- Experience sharing and lessons learned

Questions from the Non-exhaustive list of sample questions adopted by the FFSR initiative co-sponsors at MC13

- The majority of the questions asked came from the Questionnaire
- Most frequently asked questions:

"Noting the commitment made to fossil fuel subsidy reform under SDG 12(c) of the UN 2030 Agenda, could X please provide information about the nature, extent, design and implementation of any programmes or schemes, existing or under consideration, that support the production or consumption of fossil fuels?"

"How is X implementing commitments to accelerate efforts to rationalize and phase out harmful fossil fuel subsidies agreed at recent UNFCCC COPs and in line with UN Sustainable Development Goal 12(c)?"

"Could X please provide information if it has a catalogue of fossil fuel subsidies?"

Questions by key areas of focus

Enhancing transparency through notifications

Aligning reforms with international commitments

Understanding the specific support mechanisms for the production and consumption of fossil fuels

Requesting Members to share feedback from FFS reforms

Asking about the economic, social and environmental impacts of FFS measures

Most frequent types of questions

Requesting information on the nature, extent, design and implementation of FFS schemes / programmes.

Asking Members about participation in FFSR initiatives (WTO FFSR, APEC, G7, G20 processes) and intentions to implement measures aimed at reducing dependence on FFS.

Inquiring on the consistency of FFS reforms with international commitments.

Inquiring about commitments made to accelerate efforts to rationalize and phase out FFS (both under NDC and international agreements).

Asking about the existence of a catalogue of FFS where direct spending, price support, tax exemptions, or risk transfers are systematically tracked.

Inquiring whether Members intend to phase out certain FFS programmes, including temporary ones, and requesting Members to share feedback from FFS reforms.

Asking about the economic, social and environmental impacts of FFS measures.

Responses to questions

Clear increase in the extent of information being provided on fossil fuels subsidies and FFS reform, seemingly partly in response to more active questioning from FFSR initiative members.

For instance, information on:

Canada's Inefficient Fossil Fuel Subsidies Self-Review Assessment Framework and Guidelines Ukraine's phasing out of fossil fuel support through energy pricing adjustments, carbon taxation, and investments in renewable energy.

Nigeria's subsidy on diesel, removed in 2003, and the one on Premium Motor Spirit (PMS), removed in 2023.
