I. Paperless declaration to achieve one-stop business processing for cross-border trade.

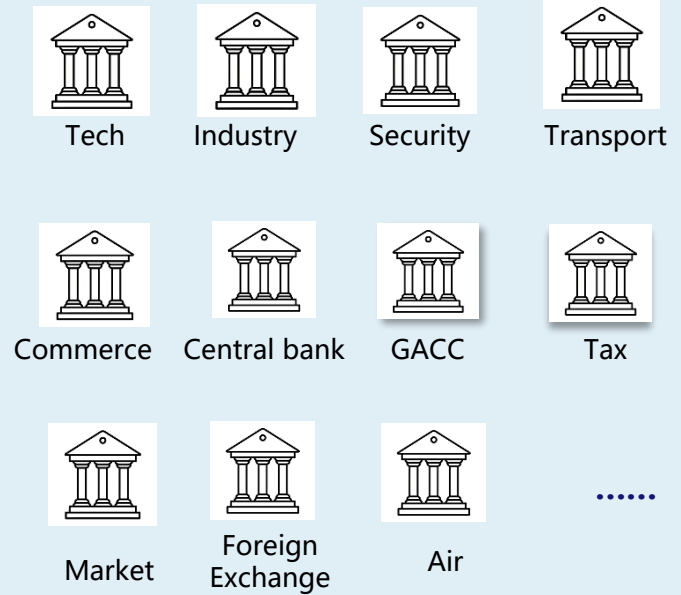

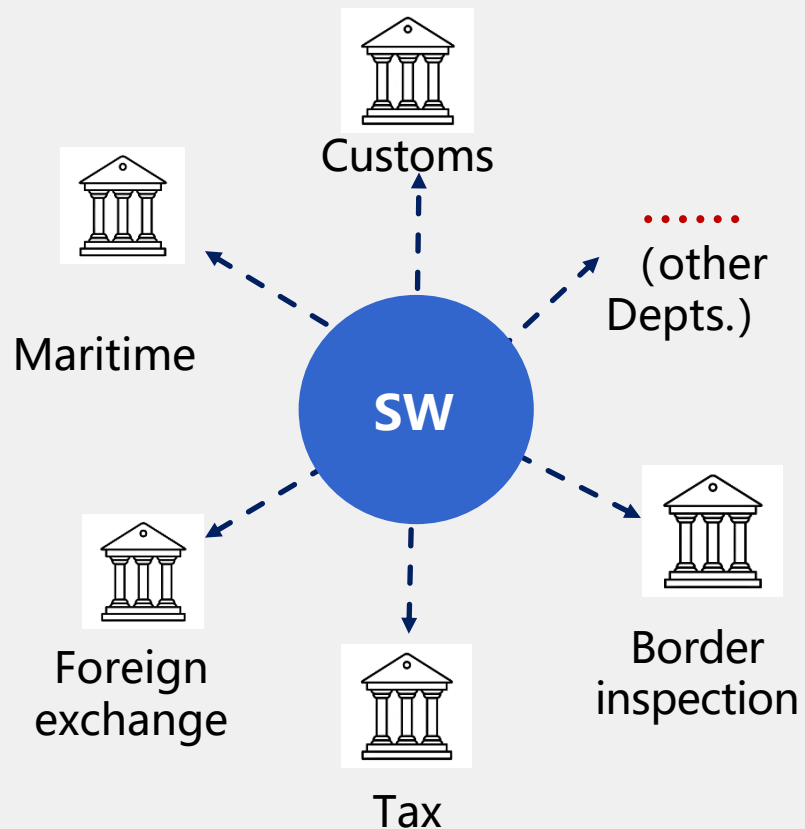

By simplifying the process and lowering the threshold, MSMEs can efficiently complete customs clearance without a professional team.

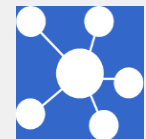


II. Information sharing to improve efficiency on enterprise compliance and regulatory approval.



Regulatory documents

Undergo a streamlined "**one-stop acceptance**" process and online verification.



Export tax refunds

Reuse customs declaration data to achieve a remarkable **90%** reduction of workload for enterprises.



One declaration to multiple agencies

Transform the approval procedures of customs, maritime, and border inspection agencies for international vessels entering and exiting the country from a **sequential** to a **parallel** process.

1. Trade + Finance

Effectively alleviate the problem of difficult and expensive financing for MSMEs and enhancing their ability to resist risks.

2. Clearance + Logistics

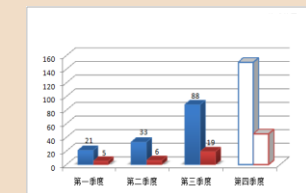
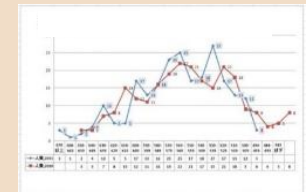
Avoid demurrage fees or default risks caused by information lag for MSMEs.

Display the entities, titles and standards of port fees and charges, and other related information.

3. Release time analysis

Clearance logistics full process evaluation provides auxiliary decision-making support for MSMEs.



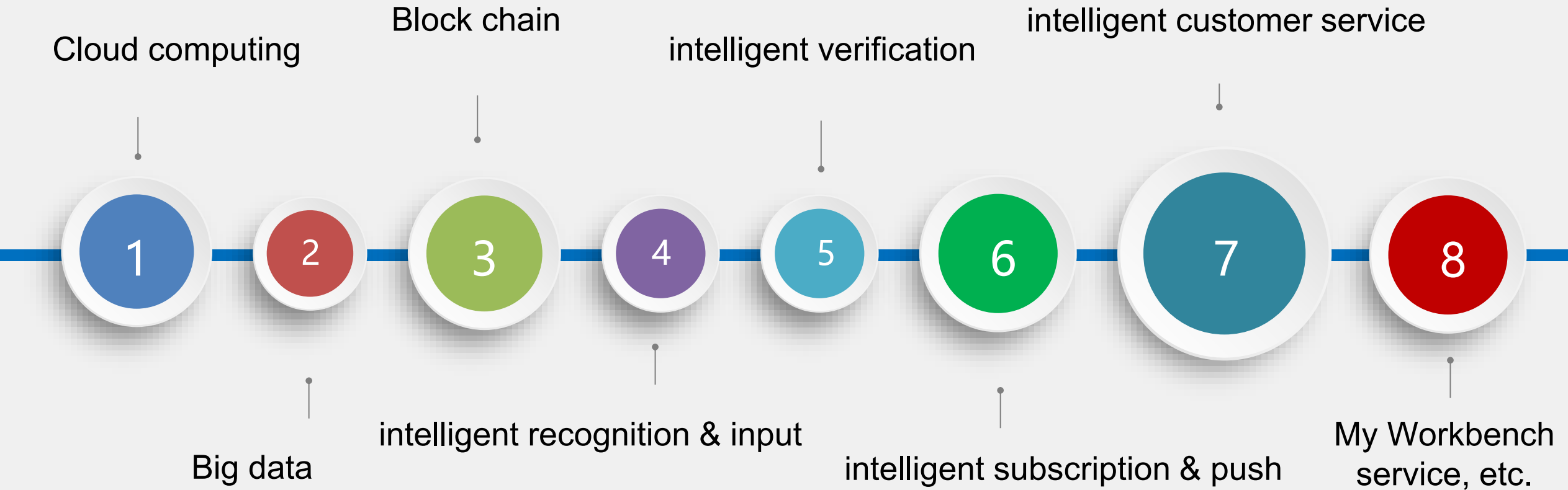


IV. Single window interconnection to promote global trade facilitation and prosperous development
