The importance of harmonization of phytosanitary measures

- Harmonized plant health standards, the ISPMs, provide assurances to all those applying them in trade that the commodities being exported and imported are free from harmful pests and diseases.
- The application of the ISPMs developed harmoniously reduces confusion and endless negotiations between trading partners as concerns processes and procedures for market access.
- The IPPC has within its framework and governance procedures the component on implementation of the Convention and its standards.

IPPC initiatives:

- 2. Implementation Review and Support System (IRSS):
- Review the extent to which contracting parties and their NPPOs implement the IPPC and its standards and identify ways to support improved implementation.
- Two general surveys on implementation of the IPPC and ISPMs (2012 and 2016)




Figure 1: Implementation of ISPMs - highest level of implementation highlighted

IPPC initiatives: Implementation Review and Support System (IRSS)




Figure 2: Implementation of ISPMs - lowest level of implementation highlighted





IPPC initiatives: Implementation Review and Support System (IRSS)

Factors influencing implementation:

- This ISPM is not very relevant
- This ISPM is highly or moderately relevant
- This standard is easy/difficult to implement
- There are (in)sufficient qualified personnel to support implementation
- (In)sufficient support for financial resources (such as budget and funding)
- (In)sufficient infrastructure supporting the implementation of this ISPM
- (In)sufficient facilities supporting the implementation of this ISPM
- Insufficient/good communication and coordination among stakeholders
- (Non-)availability of long-term supporting policies and operational plans







An overview on the implementation of the IPPC standards

- International cooperation is key.
- **Implementation of the IPPC** involves **collaboration** by national plant protection organizations (**NPPOs**).
- Through the suite of ISPMs and capacity development programmes, the Commission provides the framework for the NPPOs and the support to help NPPOs build capacity to carry out their functions.
