
EDB – NOTIFIED DATA

• Between 2009 – 2020, there are <u>4629</u> notified TrCMs in the EDB

- Breakdown by environment-related "objective"*
 - Climate Change Mitigation and Adaptation (897)
 - Afforestation/reforestation (184)
 - Alternative and renewable energy (1551)
 - Energy conservation and efficiency (1870)
 - Air pollution reduction (839)
 - Ozone layer protection (473)

* A notified measure may be tagged to more than one objective



OVERVIEW OF TRCMS

Types of policy instruments	Objectives of intervention	Potential trade effects
<i>Climate requirements – condition</i> <i>access to the market</i> - e.g. Product/production specifications, voluntary/mandatory, characteristics/ performance, labelling, quotas, bans	Improve resource use & reduce pollutants, e.g. for energy efficiency	Restrictions to trade? Necessary/balanced/adapted to outcomes sought and particular conditions?
<i>Price & market mechanisms</i> , e.g. Environmental taxes, Emission Trading Schemes (ETS)	Internalize env'tal costs, e.g. for environmental pollution or degradation	Impose costs on production/to consumers? Adjustable at the border?
<i>Support and financial programmes,</i> e.g. R&D, fiscal, price and investment measures, gov procurement	Promote development & deployment of low- carbon technologies	Introduce market, trade distortions in the economy? Lock-in certain technologies/barriers to incumbents?
